BY THE COMMISSION:

O R D E R

Pacific Gas and Electric Company, a corporation, and
E. B. Skeels, engaged in mining operations in Placer County,
having filed an application with the Railroad Commission request-
ing approval of a written agreement in accordance with the words
and figures as written in the copy thereof marked Exhibit "A"
and attached to the application herein, said agreement providing,
among other things, for the sale and delivery by Pacific Gas
and Electric Company to said E. B. Skeels for mining purposes on
certain properties located in the southwest quarter (SW $\frac{1}{4}$) of
Section 17, Township 11 North, Range 7 East, M.D.B.&M., in
Placer County, California, such quantity of excess water avail-
able in Pacific Gas and Electric Company's East Side Canal not
exceeding a flow of forty (40) miners inches,⁽¹⁾ to be paid for
at the rate of sixteen cents (\$0.16) per miners inch day,⁽²⁾ said

1. A miners inch for the purpose of this agreement shall mean
1.5 cubic feet of water per minute.

2. For the purpose of this agreement a miners inch day shall
mean one miners inch as heretofore defined flowing for a period
of twenty-four hours.

agreement to be effective for a period of one (1) year from and after the date hereof and thereafter until terminated at the election of either Pacific Gas and Electric Company or E.B. Skeels by service on the other party of written notice to that effect thirty days in advance of the date on which such termination shall become effective, and it appearing that this is not a matter in which a public hearing is necessary and that the application should be granted,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company, a corporation, and E.B. Skeels be and they are hereby authorized to enter into an agreement for the delivery of water under substantially the same terms and conditions as are set forth in the form of agreement marked Exhibit "A" attached to the application herein and made a part hereof by reference.

IT IS HEREBY FURTHER ORDERED that the Pacific Gas and Electric Company, a corporation, file with this Commission, within thirty (30) days from the date of this Order, two certified copies of said agreement as finally consummated.

The authority herein granted shall become effective on the date hereof.
