O R D E R

Pacific Gas and Electric Company, a corporation, and
Thos. L. Mitchell, owner of certain mining property located in
Section 36, Township 16 North, Range 10 East, M.D.B. & M., near
Alta in Placer County, California, having filed an application
with the Railroad Commission requesting approval of a written
agreement in accordance with the words and figures as written
in the copy thereof marked Exhibit "A" and attached to the ap-
plication herein, said agreement providing, among other things,
for the sale and delivery by said Pacific Gas and Electric Company
to said Thos. L. Mitchell for mining purposes of such quantity of
excess water available in Pacific Gas and Electric Company's
Little Towle Canal, Placer County, as shall be requested by him,
not exceeding a flow of five (5) miner's inches,⁽¹⁾ to be paid
for at the rate of thirty cents (30¢) per miner's inch day,⁽²⁾

1. A miner's inch for the purpose of this agreement shall mean
1.5 cubic feet of water per minute.

2. For the purpose of this agreement a miner's inch day shall
mean one miner's inch as heretofore defined flowing for a period
of twenty-four hours.

said agreement to be effective for a period of one (1) year from and after the date of its execution and thereafter until terminated at the election of either Pacific Gas and Electric Company or Thos. L. Mitchell by service on the other party of written notice to that effect thirty (30) days in advance of the date on which such termination shall become effective, and it appearing that this is not a matter in which a public hearing is necessary and that the application should be granted, now, therefore,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company, a corporation, and Thos. L. Mitchell be and they are hereby authorized to enter into an agreement for the delivery of water under substantially the same terms and conditions as are set forth in the form of agreement marked Exhibit "A" attached to the application herein and made a part hereof by reference.

IT IS HEREBY FURTHER ORDERED that the Pacific Gas and Electric Company, a corporation, file with this Commission, within thirty (30) days from the date of this Order, two certified copies of said agreement as finally consummated.

The authority herein granted shall become effective on the date hereof.
