FIRST SUPPLEMENTAL ORDER

Good cause appearing,

IT IS HEREBY ORDERED that applicant be and hereby is  
authorized to amend its route, as set forth in Decision No.  
27548 herein, to read as follows:

"Beginning at 10th and Eye Streets of the City of  
Sacramento, County of Sacramento, State of California;  
thence South on 10th Street to Jay Street; thence  
westerly along Jay Street to Second Street; thence  
northerly along Second Street to Eye Street; thence  
across the Sacramento River via the Southern Pacific  
Bridge to Third Street of the Town of Washington,  
County of Yolo, State of California; thence southerly  
along Third Street of said town to Ann Street of said  
town; thence Westerly along Ann Street of said town  
to Fifth Street of said town; thence Southerly along  
Fifth Street of said town to the State Highway; thence  
Westerly along the State Highway to the West Sacramento  
Road; thence Southerly along the West Sacramento Road  
to 15th Street of the Town of West Sacramento, County  
of Yolo, State of California; thence westerly along  
15th Street of said town to the West Acre Road of  
said town; thence northerly along the West Acre Road  
to the State Highway; thence westerly along the State  
Highway to the Riverloam Road; thence northerly along  
the Riverloam Road to Rose Orchard Station and the  
River Road; thence southerly along the River Road to  
the Bayer Road in Riverbank Subdivision; thence  
northerly on said Bayer Road to the Riverbank Road;  
thence easterly on the Riverbank Road to a road dividing

Riverbank Subdivision and the D. W. Hobson Sub-division; thence southerly along said road to the River Road; thence easterly along the River Road to Fifth Street in the town of Broderick, County of Yolo, State of California; thence Southerly along Fifth Street of said town to Ann Street of said town; thence Easterly along Ann Street of said town to Third Street of said Town; thence northerly along Third Street of said town to the Southern Pacific Bridge; thence across the Southern Pacific Bridge to Eye Street of the City of Sacramento, County of Sacramento, State of California; thence Easterly along Eye Street to the place of beginning."
