## BY THE COMMISSION:

## OPINION

In this proceeding the Los Gatos Telephone Company asks permission to issue and sell at par 1500 shares of its capital stock having a par value of \$10.00 per share, and use the proceeds for the purposes hereinafter stated.

The Los Gatos Telephone Company owns and operates a telephone system in the City of Los Gatos and surrounding territory. At the end of 1934 it owned 1555 stations. Its operating revenues for 1934 are reported at \$47,631.23 and its operating expenses, including depreciation and taxes, at \$36,371.23, leaving an operating income of \$11,260.00. In addition, applicant reports nonoperating income of \$41.14, which, added to the \$11,260.00, makes a total of \$11,301.14 available for interest, dividends and surplus.

As of December 31, 1934 Los Gatos Telephone Company reports assets and liabilities as follows:-

Howard Tyson, goneral manager of the Los Gatos Telephone Company, has informed us that the installation of the aforementioned additions and betterments is necessary in order to maintain and improve applicant's service.

#### ORDER

Los Catos Telephone Company having asked permission to issue 1500 shares (\$15,000. par value) of its common capital stock, the Commission having considered applicant's request and being of the opinion that this is not a matter in which a public hearing is necessary, that the money, property or labor to be procured or paid for through the issue of such stock is reasonably required by applicant for the purposes herein stated, and that the expenditures for such purposes are not in whole or in part reasonably chargeable to operating expenses or to income, and that this application should be granted, as herein provided, therefore,

IT IS HEREBY ORDERED that Los Gatos Telephone Company be, and it is hereby, authorized to issue and sell to its stockholders, at not less than par, 1500 shares (\$15,000. par value) of its common capital stock and use the proceeds for the following purposes:-

IT IS HEREBY FURTHER ORDERED that Los Gatos Telephone Company shall keep such record of the issue and sale of the stock herein authorized and of the disposition of the proceeds as will enable it to file on or before the 25th day of each month a verified report, as required by the Railroad Commission's General Order No. 24, which order insofar as applicable, is made a part of this order.

IT IS HERRERY FURTHER ORDERED that the authority herein granted will apply only to such stock as may be issued and sold on or before March 1, 1936.
