In the Matter of the application of PACIFIC ELECTRIC RAILWAY COMPANY for authority to shift spur track at grade across Railroad Street, in the City of Corona.

BY THE COMMISSION:

ORDER

Pacific Electric Railway Company, a corporation, on January 7, 1936, applied for authority to construct a track at grade across Railroad Street in the City of Corona, County of Riverside, State of California. The necessary franchise or permit (Resolution No. 196) has been granted by the City Council of said City for the construction of said crossing at grade.

It appearing that a public hearing is not necessary herein; that it is neither reasonable nor practicable at this time to provide a grade separation or to avoid a grade crossing at the point mentioned and that the application should be granted,

IT IS HEREBY ORDERED that Pacific Electric Railway Company is hereby authorized to construct a track at grade across Railroad Street in the City of Corona, County of Riverside, State of California, at the location more particularly described in the application and as shown by the map (C.E.H. 14789-a) attached thereto, subject to the following conditions:

> (1) The above crossing of Railroad Street shall be identified as Crossing No. 6W-14.70;

(2) The entire expense of constructing and thereafter maintaining the crossing in good and first-class condition for safe and convenient use of the public shall be borne by applicant.

- (3) Said crossing shall be constructed equal or superior to the type shown as Standard No. 2, in our General Order No. 72, and shall be constructed without superelevation and of a width to conform to that portion of said street now graded, with the tops of rails flush with the pavement and with grades of approach not exceeding four (4) per cent, and shall be protected by a Standard No. 1 crossing sign, as specified in our General Order No. 75-A.
- (4) Applicant shall remove the track shown in yellow on the map (C.E.H. 14789-a) attached to the application in so far as it lies in Railroad Street, and shall repair the roadway to conform to the remainder thereof.
- (5) Applicant shall, within thirty (30) days there-after, notify this Commission, in writing, of the completion of the installation of said crossing and of its compliance with the conditions hereof.
- (6) The authorization herein granted shall lapse and become void if not exercised within one (1) year from the date hereof, unless further time is granted by subsequent order.
- The Commission reserves the right to make such (7) further orders, relative to the location, con-struction, operation, maintenance and protection of said crossing, as to it may seem right and pro-per and to revoke its permission if, in its judgment, public convenience and necessity demand such action.

The authority herein granted shall become effective on the date hereof.
