
Decision No. 28608.

BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of PACIFIC GAS AND ELECTRIC COMPANY for an order of the Railroad Commission of the State of California approving a certain agreement entered into by and between applicant and OSCAR HOTTINGER (LOG CABIN BAKERY), dated December 20, 1935.

BY THE COMMISSION:

OPINION AND ORDER

Pacific Gas and Electric Company, a California corporation, requests approval of a special agreement dated December 20, 1935, that it has negotiated with Oscar Hottinger (Log Cabin Baking Company) for the sale and furnishing of gas service, a copy of which is marked Exhibit "A" and attached to and made a part of the application.

Under the terms and conditions and during the term specified in the agreement dated December 20, 1935, applicant has agreed to sell and deliver to Oscar Hottinger (Log Cabin Baking Company) and the latter has agreed to purchase from the former, all gas which said Oscar Hottinger shall require for the operation of his bakery equipment and the conduct of his baking business upon his premises situate at 5034 Fifth Street in the City of Chico, County of Butte, State of California, all in accordance with the rules and regulations duly and regularly established from time to time and on file with the Railroad Commission.

The term of the agreement is three (3) years from and after December 20, 1935, and thereafter until terminated by thirty (30) days written notice by either party. The rates and charges set forth in the agreement are as follows:

\$0.50 per 1000 cubic feet of gas per month. Minimum charge \$100.00 per month.

The above rates for gas will be increased by one (1) cent for each ten (10) cents (or major portion thereof) increase in the price of Diesel oil above \$1.47 per barrel delivered to the Company's Marysville gas plant, the change to become effective on all regular meter readings taken on and after the 30th day following such change in the price of oil.

Applicant alleges that the rates to be accorded the consumer under said agreement are lower than those heretofore available under applicant's regularly published schedules and that justification therefor is the impending loss of the load resulting from the consumer's preparedness to install and use oil-burning equipment. Applicant also further states that in addition to the aforementioned load, supplemental load that is now being served by means of competitive fuel will be obtained from said consumer.

The agreement contains a provision that it shall at all times be subject to such changes or modifications by the Railroad Commission of the State of California as said Commission may from time to time direct in the exercise of its jurisdiction.

The Commission is of the opinion that the agreement dated December 20, 1935, is in the interests of all parties, that it will not constitute a burden upon any consumer, but will

tend to benefit all consumers, that a public hearing in the matter is not necessary and good cause appearing therefor,

IT IS HEREBY ORDERED that the above mentioned agreement between Pacific Gas and Electric Company and Oscar Hottinger (Log Cabin Baking Company) dated December 20, 1935, be and the same is hereby approved.
