BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of PACIFIC GAS AND ELECTRIC COMPANY, a corporation, and G. R. HENDRIX for an order of the Railroad Commission of the State of California authorizing applicants to enter into a written agreement in words and figures as written in the form therefor which is annexed hereto.

BY THE COMMISSION:

Pacific Gas and Electric Company, a corporation, and G.R. Hendrix, owner of certain mining lands and desirous of engaging in mining operations thereon if and when he can secure the necessary supply of water for such purposes, having filed an application with the Railroad Commission requesting approval of a certain agreement entered into by and between the above applicants in accordance with the words and figures as written in the copy thereof marked Exhibit "A" attached to the application herein, said agreement providing, among other things, for the sale and delivery by Pacific Gas and Electric Company to said G.R. Hendrix for mining purposes on certain property located in the northwest quarter (NWE) of the southwest quarter (SWE) of Section 32, Township 22 North, Range 4 East, M.D.B. & M., Butte County, California,

such quantity of excess water available in said Company's Miocene Canal not exceeding a flow of ten (10) miner's inches, (1) to be paid for at the rate of fifteen cents (15¢) per miner's inch day, (2) same to be effective for a period of one (1) year from and after the date of its execution and thereafter until terminated at the election of either Pacific Gas and Electric Company or G.R. Hendrix by service on the other party of written notice to that effect thirty (30) days in advance of the date on which such termination shall become effective, and it appearing that this is not a matter in which a public hearing is necessary and that the application should be granted,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company, a corporation, and G.R. Hendrix be and they are hereby authorized to enter into an agreement for the delivery of water under substantially the same terms and conditions as are set forth in the form of agreement marked Exhibit "A" attached to the application herein and made a part hereof by reference.

IT IS HEREBY FURTHER ORDERED that Pacific Gas and Electric Company, a corporation, file with this Commission within thirty (30) days from the date of this Order, two certi-

^{1.} A miner's inch for the purpose of this agreement shall mean one and two-tenths (1.2) cubic feet of water per minute.

^{2.} A Miner's inch day for the purpose of this agreement shall mean one miner's inch of water as heretofore defined flowing for a period or twenty-rour (24) hours.

fied copies of said agreement as finally consummated.

The authority herein granted shall become effective on the date hereof.
