FOURTH SUPPLEMENTAL ORDER

East Bay Street Railways, Ltd., filed its supplement to Application No. 19502 on June 10, 1936, asking for permission to reroute a portion of its so-called Castro Valley Motor Coach Line in the vicinity of the City of Hayward, Alameda County.

Applicant alleges that the proposed routing will better serve the district and that it has been requested by the City of Hayward and residents of the area to place said rerouting in effect.

It appears that this is not a matter in which a public hearing is necessary and that this supplemental application should be granted, therefore,

IT IS HEREBY ORDERED that permission and authority be and the same is hereby granted to East Bay Street Railways, Ltd., to abandon that portion of its so-called Castro Valley Motor Coach Line now commencing at "A" and 1st Streets, thence along "A" Street to Redwood Road, thence along Redwood Road to Castro Valley Boulevard; and in lieu thereof to substitute the route commencing at the intersection of "A" and 1st Streets, thence along 1st Street to "B" Street, thence along "B" Street to Center

Street, thence along Center Street to Castro Valley Boulevard and along Castro Valley Boulevard to Redwood Road. The description of the entire line as rerouted is as follows:

Commencing at the intersection of Castro Street and "A" Street in the City of Hayward, thence along "A" Street to 1st Street, along 1st Street to "B" Street, along "B" Street to Center Street, along Center Street to Castro Valley Boulevard, along Castro Valley Boulevard to Foothill Boulevard, along Foothill Boulevard to Sybil Avenue, along Sybil Avenue to the intersection of Sybil Avenue and East 14th Street,"

subject, however, to the following conditions:

- (1) Applicant shall give not less than five (5) days' notice to the public of said rerouting, by posting notices in motor coaches operating along said route.
- (2) Applicant shall, within thirty (30) days thereafter, notify this Commission, in writing, of the placing in effect of said rerouting.
- (3) The authorization herein granted shall lapse and become void if not exercised within one (1) year from the date hereof, unless further time is granted by subsequent order.

The authority herein granted shall become effective on the date hereof.
