## ORDER

Pacific Gas and Electric Company, a corporation, having filed an application with the Railroad Commission requesting approval of a certain agreement entered into by and between Pacific Gas and. Electric Company, a corporation, and T. T. Wiseman, in words and figures as set forth in the copy thereof marked Exhibit "A" and attached to the application herein, said agreement providing, among other things, that as the Company has abandoned a portion of its Boardman Canal in the vicinity of Monte Vista through which it had heretofore furnished irrigation service at a continuous flow of one miner's inch<sup>(1)</sup> of water but has now substituted therefor a pumping plant, tank and pressure pipe line (called Monte Vista System) through which irrigation service will be supplied; that the Company will sell from said Monte Vista System to said T. T. Wiseman for irrigation of his land such quantity of water as the latter shall, from time to time, require therefor, not exceeding a continuous flow of one inch, to be paid for at a rate of thirty cents (\$0.30) per miner's inch day, (2) said water (1) For the purpose of this agreement a miner's inch shall mean one and one-half (12) cubic feet of water per minute. (2) For the purpose of this agreement a miner's inch day shall

be 2160 cubic feet of water.

to be used on certain land located in the Northeast quarter (NEZ) of Section 3, Township 15 North, Range 10 East, M.D.B.& M. near Monte Vista, Placer County, California, said agreement shall continue in force and effect so long as said T. T. Wiseman desires to continue the use of water under the conditions thereof, unless terminated in the manner in said agreement provided. It appearing that this is a matter in which a public hearing is not necessary and that the application should be granted; now therefore,

IT IN HEREBY ORDERED that Pacific Gas and Electric Company, a corporation, and T. T. Wiseman be and they are hereby authorized to enter into an agreement for the delivery of water under substantially the same terms and conditions as are set forth in the form of agreement marked Exhibit "A" attached to the application herein and made a part hereof by reference.

IT IS HEREBY FURTHER ORDERED that the Pacific Gas and Electric Company, a corporation, file with this Commission, within thirty (30) days from the date of this Order, two certified copies of said agreement as finally consummated.

The authority herein granted shall become effective on the date hereof.
