FIRST SUPPLEMENTAL ORDER OF SUSPENSION AND INVESTIGATION

By order dated July 13, 1936, the Commission suspended until October 12, 1936, Supplement 39 to Southern Pacific Company's Special Local and Joint Freight Tariff No. 3134, C.R.C. No. 3469; Item 760-E to The Western Pacific Railroad Company's Freight Tariff G.F.D. No. 675, C.R.C. No. 337; Item 7920-D to Pacific Freight Tariff Bureau Tariff No. 1-P, C.R.C. No. 588 of L. F. Potter, Alternate Agent, and Items 13630-A, 13640-A, 13650-A and 13660-A to Pacific Freight Tariff Bureau Tariff No. 167-L, C.R.C. No. 586 of L. F. Potter, Alternate Agent, providing reduced rates for the transportation of petroleum and petroleum products between various points in California.

It now appears that while the aforesaid rates were being considered by the Commission there were filed by Pacific Freight Tariff Bureau, L. F. Potter, Alternate Agent, to become effective August 15, 1936, Item 7920-E to its Tariff No. 1-P, C.R.C. No. 588, and, to become effective August 31, 1936, Items 13630-B, 13640-B, 13650-B and 13660-B to its Tariff No. 167-L, C.R.C. No. 586, re-

publishing certain of the rates heretofore suspended; and the Commission being of the opinion that the effective date of these items should be likewise postponed pending a determination of the reasonableness, lawfulness and propriety of the rates heretofore suspended,

IT IS HEREBY ORDERED that the operation of the tariff items enumerated in the paragraph next preceding be suspended and the use thereof be deferred until October 12, 1936, unless otherwise ordered by the Commission, and that no changes shall be made in such items during the period of suspension or any extension thereof unless authorized by special permission of the Commission.

IT IS HEREBY FURTHER ORDERED that a copy of this order be filed with the schedules in the office of the Railroad Commission of the State of California and that a copy thereof be forthwith served upon Pacific Freight Tariff Bureau, L. F. Potter, Alternate Agent.
