BY THE COMMISSION: SUPPLEMENTAL ORDER By its Decision No. 28057, dated June 24, 1935, the Commission approved an agreement entered into by and between Pacific Gas and Electric Company and Russ Building Company dated April 1, 1935, whereunder for the initial term of five (5) years from and after April 1, 1935, the former agreed to furnish electric power to the latter at the following rates: Demand Charge: First 800 kilowatts or less of Maximum Demand...... \$1,500.00 per month All over 800 kilowatts of Maximum Demand...... \$0.75 per K.W. per mouth Energy Charge (To be added to the Demand Charge):
All energy at six mills (\$.006) per kilowatt-hour Fuel Oil Clause: The above energy rate is subject to increase on the basis of 1/10 mill per kilowatt-hour for each 3.5 cents increase in the market price of fuel oil as regularly quoted by the Standard Oil Company of California, from 89 cents per barrel f.o.b. Richmond, California, such increase to be computed to the nearest 1/10 mill per kilowatt hour. Maximum Demand: The maximum demand in any month will be the average kilowatt delivery of the 15-minute interval in which such delivery is greater than in any other 15-minute interval in the month.

Effective January 1, 1956, Pacific Gas and Electric Company filed its Schedule C-4, applicable to commercial electric light and power service, the rate in said schedule being lower than that above quoted from the contract dated April 1, 1935.

Pacific Gas and Electric Company now requests, in writing, under date of June 15, 1936, that the Commission issue its supplemental order approving a supplemental agreement dated May 22, 1936, between said parties which amends said contract of April 1, 1935, only as to the rate charged and states:

"The rates and charges to be paid by consumer for electric energy and service to be furnished under said agreement of April 1, 1935, shall, from and after the first day of January, 1936, be in accordance with Power Company's Schedule C-1, a true copy of which is hereunto annexed and made a part hereof, the rates and charges specified in which are legally established and applicable to the service requested by consumer, to-wit, Commercial Light and Power (Alternating Current)."

The Commission being of the opinion that this request is fair and reasonable and should be granted, that a public hearing in the matter is not necessary and good cause appearing therefor,

IT IS HEREBY ORDERED that the above mentioned supplemental agreement between Pacific Gas and Electric Company and Russ Building Company dated May 22, 1936, be and it is hereby approved.
