ORDER AMENDING DECISION AND DENYING REHEARING

Sacramento Northern Railway and The Western Pacific Railroad Company having filed a petition for rehearing or modification of Decision No. 29290, California-Nevada Stages, Inc. having filed a petition for rehearing of said decision, and good cause appearing,

IT IS ORDERED that condition (2) on page 16 of Decision No. 29290 is hereby amended to read as follows:

"(2) No passengers, baggage or express shall be transported between Yuba City-Marysville and the south bridgehead of Yuba River bridge on Highway U.S. 99E (adjacent to the south city limits of the City of Marysville) on the one hand and North Sacramento-Sacramento on the other."

And

IT IS FURTHER ORDERED that condition (2) on page 19 of Decision No. 29290 is hereby amended to read as follows:

- "(2) No passengers, baggage or express shall be transported between San Francisco-Oakland and/or Sacramento on the one hand and the territory along, between and including Roseville and Chico on the other, either
 - (a) via Red Bluff or Proberta, or
 - (b) via the route herein authorized between Roseville and Chico upon and along Highway U. S. 99E."

Said decision in all other respects to remain in full force and effect; and

The Commission having considered each of said petitions for rehearing, and being of the opinion that no good cause appears therein for the granting of a rehearing of said decision, as amended herein,

IT IS FURTHER ORDERED that said petitions are hereby denied.
