BY THE COMMISSION: FIRST SUPPLEMENTAL ORDER Beverly Gibson, applicant in Application No. 19969, on June 7, 1937, filed with the Commission a request asking for an extension of time of thirty (30) days from the time limit mentioned in conditions (1) and (2) of Part III of Decision No. 29781, dated May 24, 1937, for the augmentation of service between Rio Vista and Rio Vista Junction. Applicant Gibson alleges that if the augmented service between Rio Vista and Rio Vista Junction is inaugurated prior to the commencement of service between the Delta area and San Francisco, the commuters north of Rio Vista will, during the interval, be without proper through service; that it is desirable that both the change in service between Rio Vista and Rio Vista Junction and the inauguration of service to San Francisco be commenced concurrently; that the equipment proposed to be used in the San Francisco service will not be ready at the time mentioned for the augmentation of the Rio Vista-Rio Vista Junction service; and that public convenience and necessity of the entire Delta area will be better served if an extension of time is granted as prayed for. It appears that this is not a matter in which a public hearing is necessary and that said request should be granted, therefore, IT IS HEREBY ORDERED that conditions (1) and (2) of Part III of said Decision No. 29781 be amended to read as follows: Applicant shall commence the service herein required within a period of not to exceed forty-five (45) days from the effective date hereof. (2) Applicant shall file, in duplicate, within a period of not to exceed forty-five (45) days from the date hereof, time schedules covering the coordinated service herein required. In all other respects Decision No. 29781 shall remain in -2full force and effect.
