THIRD SUPPLEMENTAL OPINION AND ORDER

By petition July 2, 1937, Pacific Motor Transport Company seeks modification of Decision No. 29618 of March 22, 1937, in the above entitled proceedings wherein a rate of 65 cents per 100 pounds, 30,000 pounds minimum, was established for the transportation of fresh pears in packages from points in Lake County to Los Angeles. Petitioner represents that unless this rate is reduced to 60 cents per 100 pounds shippers will not forward shipments directly to Los Angeles but will arrange to route their shipments in such a manner as will permit the application of combination rates lower in volume : than the presently established through rate and that consequently it will not be in a position to compete for this traffic.

The Commission's attention has also been directed to an inedvertence in the explanation of the symbol *** appearing at the

bottom of Page 4 of Appendix "A" of Decision No. 29618, which should read, from points of origin, instead of "to points of destination."

After consideration of these matters the Commission is of the opinion that a formal hearing is not necessary, that the petition should be granted and that the inadvertence should be corrected; therefore, good cause appearing,

IT IS HEREBY ORDERED that Appendix "A" of Decision No. 29618 of March 22, 1937, in the above entitled proceedings, be and it is hereby amended as follows:

<u>Page 3</u> - Rates in cents per 100 pounds on Fresh Pears in packages from points of origin in Lake County not more than 20 miles distant by highway from Lakeport to points of destination located within the corporate limits of Los Angeles. Minimum Weight 30,000 pounds.

<u>Page 4</u> - Rates in cents per 100 pounds on empty carriers, returned, or when shipped for a return pay load via the same carrier as the outbound movement to points of destination in Lake County not more than 20 miles distant by highway from Lakeport, from points of origin located within the corporate limits of Los Angeles.
