SECOND SUPPLEMENTAL ORDER

Request having been made by R. Lindemann of Los Banos, California, that certain parcels of land now within the service area of The San Joaquin & Kings River Canal & Irrigation Company, Incorporated, be excluded from said area and that certain land in lieu thereof be included therein and that said land to be included be entitled to irrigation service from the company's canals on the same basis as other lands admitted to service as set out in the Commission's Decision No. 29501, dated February 1, 1937, an investigation having been made in the matter and written consent therefor having been obtained from the company, now, therefore,

IT IS HEREBY ORDERED that the following parcels, viz.,

PARCEL NO. 1. Beginning at the northeast corner of Section 33, Township 11 South, Range 11 East, M.D.B. & M., thence along the east line of Section 33, south  $0^{\circ} 05-1/2'$  west 2663.00 feet, thence leaving section line north

89° 38' west 2163.23 feet, thence along the easterly line of Outside Canal north 47° 48' west 659.37 feet, thence leaving canal, north 0° 11' west 2218.70 feet, thence along the north line of Section 33, south 39° 44-1/2' east 2663.00 feet to the point of beginning, containing 159.81 acres, more or less, and being located in the County of Merced, California.

PARCEL NO. 2. Beginning at the southwest corner of Section 27, Township 11 South, Range 11 East, M.D.B. & M., thence along the west line of Section 27, North 0° 31-1/2' east 806.20 feet, thence along the southerly right of way line of Main and Parallel Canals, a 250 foot reservation, south 76° 15-1/2' east 1015.96 feet, south 69° 14-1/2' east 195.84 feet, south 60° 37-1/2' east 184.83 feet, thence along the center line of a ditch, south 1° 03' west 441.87 feet to a point on the north line of Section 34 (which point is south 88° 29-1/2' east 1330.85 feet, from the southwest corner of Section 27), thence along the center line of aforesaid ditch, south 1° 03' west 2662.00 feet, thence leaving ditch north 38° 32' west 1329.00 feet, thence along the west line of Section 34, north 1° 00-1/2' east 2663.00 feet to point of beginning (North 1° 00-1/2' east equals south 0° 05-1/2' west for Section 33), containing 101.33 acres, more or less, and being situated in the County of Merced, California.

PARCEL NO. 3. A strip of land bounded on the northeasterly side by the southwesterly right of way line of the Main Canal of The San Joaquin & Kings River Canal & Irrigation Company, on the north side by the north line of Section 29, Township 11 South, Range 11 East, on the southwesterly side by a line parallel to the southwesterly right of way line of the Main Canal of The San Joaquin & Kings River Canal & Irrigation Company, and on the east by the east line of Section 29, Township 11 South, Range 11 East, containing 58.86 acres, more or less, and being situated in the County of Merced, California.

be excluded from the service area of The San Joaquin & Kings River Canal & Irrigation Company, Incorporated, and that the following described land, viz.,

The north half of Section 26, Township 11 South, Range 10 East, M.D.B. & M., containing 320 acres, more or less, and being situated in the County of Merced, California,

be and it is hereby included within the service area of The San

Joaquin & Kings River Canal & Irrigation Company, Incorporated,  
and said land shall be entitled to irrigation service from the  
company's canals on the same basis as those lands admitted to ser-  
vice as set out in the Commission's Decision No. 29501, dated  
February 1, 1937.

The authority herein granted shall become effective on  
the date hereof.
