OPINION AND ORDER

Pacific Greyhound Lines, applicant herein, heretofore by
Decision No. 23244 has been granted, among other rights, an operating
right, with certain restrictions, between Los Angeles and Long
Beach in general over the route Sixth Street, San Pedro Street,
Avalon Boulevard. Florence Avenue and Long Beach Boulevard.

By this application applicant is requesting the authority of the Commission to reroute its existing service between Los Angeles and Long Beach over the following route:

"Via Sixth Street, Los Angeles, to San Pedro Street, thence on San Pedro Street to Avalon Boulevard, thence on Avalon Boulevard to Florence Avenue, thence on Florence Avenue to State Street; thence on State Street to the intersection with Long Beach Boulevard, or continuing on Florence Avenue, thence on Long Beach Boulevard to Long Beach."

As justification therefor, applicant refers to an informal complaint which has been filed with the Commission by the residents along the present route protesting the use of such route by applicant for the operation of its stages.

As further justification for the rerouting, applicant alleges that it has changed the location of its agency in this district to a new location on Florence Avenue and in order to provide service to said agency the rerouting herein sought is necessary.

Written waivers of protest to the granting of the authority sought having been received from competing carriers in the territory

involved, it does not appear that a public hearing is necessary and the request will be granted.

Therefore, good cause appearing,

IT IS ORDERED that in the place and stead of the route of applicant between Los Angeles and Long Beach as set forth at sheet 15 of Decision No. 23244, dated December 31, 1930, reading:

"72- Between Los Angeles and Long Beach via Sixth Street, Los Angeles, to San Pedro Street, thence on San Pedro Street to Avalon Boulevard, thence on Avalon Boulevard to Florence Avenue, thence on Florence Avenue to Long Beach Boulevard, thence on Long Beach Boulevard to Long Beach."

there be substituted in lieu thereof the following route:

"Via Sixth Street, Los Angeles, to San Pedro Street, thence on San Pedro Street to Avalon Boulevard, thence on Avalon Boulevard to Florence Avenue, thence on Florence Avenue to State Street, thence on State Street to the intersection with Long Beach Boulevard, or continuing on Florence Avenue, thence on Long Beach Boulevard to Long Beach."

The effective date of this order shall be the date hereof.
