SECOND SUPPLEMENTAL
OPINION AND ORDER

By this supplemental application Union Pacific Stage Company seeks authority to reroute its common carrier automotive passenger and baggage service between East Los Angeles and Glendale via Pasadena as heretofore authorized by Decision No. 22761 due to the fact that there has been a change of location of the ticket office of the Union Pacific Railroad Company in the city of Glendale. No schedule change is involved.

This appears to be a matter in which a public hearing is not necessary, and

Good cause appearing,

IT IS HEREBY ORDERED that Union Pacific Stage Company be and it is hereby authorized to establish, in lieu of its present authorized route, the following route between East Los Angeles and Glendale:

East Los Angeles to Glendale:

North on Atlantic Avenue to Garvey Road,
East on Garvey Road to Garfield Avenue,
North on Garfield Avenue to Mission Street,
East on Mission Street to Los Robles,
North on Los Robles to Colorado Boulevard,
West on Colorado Boulevard to Pasadena Depot,
West on Colorado Boulevard to El Modena Street,
West on El Modena Street to Colorado Boulevard,
West on Colorado Boulevard to Broadway,
West on Broadway to Brand Boulevard,
North on Brand Boulevard to 206 North Brand
(Glendale City Office),
North on Brand Boulevard to Lexington Avenue,
East on Lexington Avenue to Geneva Street
(Glendale Depot).

Glendale to East Los Angeles:

East on Lexington Avenue to Glendale Avenue,
South on Glendale Avenue to Broadway,
West on Broadway to Brand Boulevard,
North on Brand Boulevard to Glendale Ticket Office,
North on Brand Boulevard to Lexington Avenue,
East on Lexington Avenue to Glendale Avenue,
South on Glendale Avenue to Broadway,
East on Broadway to Colorado Boulevard,
East on Colorado Boulevard to El Modena Street,
East on El Modena Street to Colorado Boulevard,
East on Colorado Boulevard to Pasadena Depot,
East on Colorado Boulevard to Los Robles Avenue,
South on Los Robles Avenue to Mission Street,
West on Mission Street to Garfield Avenue,
South on Garfield Avenue to Garvey Road,
West on Garvey Road to Atlantic Boulevard,
South on Atlantic Boulevard to Telegraph Road
(East Los Angeles Depot).

IT IS HEREBY FURTHER ORDERED that in all other respects,
save for the rerouting herein authorized, Decision No. 22761 shall
remain unchanged and in full force and effect.
