## <u>opinion</u>

This is an application by Pacific Greyhound Lines for an order of this Commission amending its certificate of public convenience and necessity so as to authorize the establishment of an alternate route between the intersection of Valley Boulevard and Mission Road at East Lake Park and South Alhambra in the operation of its automotive common carrier passenger, baggage and express service between Los Angeles and Coachella via South Alhambra. Applicant further requests that the description of routes contained in paragraphs 74 and 78 of Decision No. 23244, on Application No. 16989, as amended by Decision No. 27929, on Application No. 19925, be amended to provide for the alternate route herein sought. Applicant agrees that all conditions, limitations and restrictions now imposed by the decisions referred to shall remain unchanged and in full force and effect.

In support of its request Pacific Greyhound Lines alleges that Alhambra is a point of substantial population and that the present service of applicant, confined to the route via Valley Boulevard, permits service only to the extreme southerly part of Alhambra designated as South Alhambra. Upon establishment of the alternate route herein sought, applicant will be enabled to provide a direct service to the center of Alhambra and thereby better serve the necessities and conveniences of the public.

This appears to be a matter in which a public hearing is not necessary. The application will be granted.

## ORDER

Venience and necessity heretofore granted to Pacific Greyhound
Lines by Decision No. 23244, on Application No. 16989, and as
amended by Decision No. 27929, on Application No. 19925, be and
it is hereby further amended to establish an alternate route between the intersection of Valley Boulevard and Mission Road at
East Lake Park and South Alhambra in addition to applicant's
existing route for operation between Los Angeles and Coachella,
provided that applicant shall file in duplicate and on at least
five (5) days notice to the Commission and the public a time
schedule in duplicate showing the authority for alternate routing
horein authorized.

IT IS HEREBY FURTHER ORDERED that the description of the route set forth in paragraphs 74 and 78 of Decision No 23244, as amended by Decision No. 27929 be amended to read as follows:

Between Los Angeles and Coachella via Macy Street, Los Angeles; thence on Macy Street to Mission Road; thence on Mission Road to Alhambra Avenue with an alternate route between the intersection of Valley Boulevard and Mission Road at East Lake Park and South Alhambra (junction of Garfield Avenue and State Route 77) via Mission Road, Huntington Drive, Main Street and Garfield Avenue; thence on Alhambra Avenue to Valley Boulevard to El Monte, or as an optional route via new Ramona Boulevard and Garvey Avenue to the junction of Valley Boulevard and Garvey Avenue east of El Monte; thence via the main highway through Puente to Pomona, or via the new direct main highway from El Monte to Pomona via West Covina; thence via the main highway through Ontario and Riverside to Redlands, or via the direct main highway from

Ontario to Redlands through Guasti, Bloomington and Colton; thence via the main highway through Beaumont and Banning to Palm Springs Junction, thence either via the main highway through Edom and Indio, or via the main highway through Palm Springs and Indio.

In all other respects save for the alternate route herein authorized Decisions Nos. 23244 and 27929 shall remain unchanged, in full force and effect, and all conditions, restrictions and limitations heretofore imposed therein shall not by this decision be impaired.

The effective date of this order shall be ten (10) days from the date hereof.
