EIGHTH SUPPLEMENTAL ORDER

The Truck Owners Association of California, Valley Express Co. and Valley Motor Lines, Inc., having filed a petition for modification of Decision No. 30370, dated November 29, 1937, as amended, in the above entitled proceedings, by amending paragraph (e), Rule No. 40; a request having been received from California Western Railroad & Navigation Company for exemption as to shipments weighing 50 pounds and less transported by said carrier; and good cause appearing,

IT IS HEREBY ORDERED that paragraph (e) of Rule No. 20 of Appendix "A" to Decision No. 30370 dated November 29, 1937, as amended, in the above entitled proceedings, be and it is hereby further amended by adding as an exempted carrier California Western Railroad & Navigation Company, for transportation of shipments not

exceeding 50 pounds in weight, moving locally between points served by said carrier.

IT IS HEREBY FURTHER ORDERED that Appendix "A" of Decision No. 30370, be and it is hereby further amended as follows:

(1) Change paragraph (e), Rule No. 40, Section No. 1, to read:

"(e) Rates provided in Section 3 shall alternate with the lowest common carrier rates for the same transportation from and to the same points. (See Note)."

(2) Immediately following paragraph (e), Rule No. 40, Section No. 1, add the following:

"NOTE.-Highway carriers maintaining established depots may apply, for transportation between such depots, the rail carload rates applying between rail team tracks in the same cities or towns."

In all other respects, said Decision No. 30370, as amended, shall remain in full force and effect.

The effective date of this order shall be the date hereof.
