Under Decisions Nos. 29480, as amended, and 30370, as amended, in the above entitled proceedings, "fertilizer" and "insecticides and fungicides" were excluded from the application of the minimum rates established by said decision. It has now been represented by California Farm Bureau Federation that sulphur is utilized extensively as a fertilizer and also as an insecticide and should be similarly excluded.

IT IS HEREBY ORDERED that paragraph (c), Rule 20, Appendix "A" of Decision No. 29480, as amended in Cases Nos. 4088, Part "M", and 4145, Part "B", be and it is hereby further amended by adding the following:

"(19) Sulphur"

IT IS HEREBY FURTHER ORDERED that paragraph (e), Rule 20, Appendix "A" of Decision No. 30370, as amended in Cases Nos. 4088, Parts "U" and "V", and 4145, Parts "F" and "G", be and it is hereby further amended to read as follows:

"(e) Beans, peas and lentils, dried; fertilizers; fruit, fresh; hay and straw; insecticides or fungicides, agricultural; sulphur; live stock; nuts, edible, in the shell; vegetables, fresh or green;"

IT IS HEREBY FURTHER ORDERED that in all other respects said Decisions Nos. 29480, as amended, and 30370, as amended, shall remain in full force and effect.
