BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the matter of the application of PACIFIC GAS AND ELECTRIC COMPANY, a corporation, for an order of the Railroad Commission of the State of California authorizing applicant to enter into a written agreement with SAN FRANCISCO BAY EXPOSITION, in words and figures as written in the form therefor which is annexed hereto, etc.

This is an application of the Pacific Gas and Electric Company for an order authorizing Applicant Corporation to enter into a proposed written agreement with San Francisco Bay Exposition, a corporation, hereinafter some times referred to as Customer. A copy of this agreement is attached to and made a part of the application, as Exhibit "A."

Under the terms and conditions set forth in said agreement, Applicant company, among other things, agrees to sell and deliver to Customer, and Customer agrees to purchase from the former, all the natural gas required for any and all purposes for use at the Golden Gate International Exposition, near Yerba Buena Island in the City and County of San Francisco. For all such gas delivered, the Customer agrees to pay at the rate of fifty cents (\$.50) per one thousand (1,000) cubic feet per month.

The agreement further provides that the Applicant company will construct a four inch gas main capable of delivering at the end thereof thirty thousand (30,000) cubic feet of

natural gas per hour, and at ten (10) pounds pressure. Such gas line is to extend underground to the end of the Key Fill and thence underwater to the Exposition site. Of the total cost of approximately sixty-two thousand four hundred dollars (\$62,400.00), the Customer is to pay the Applicant one-half of the estimated cost of said gas main as shall be laid under water in the amount of twenty-five thousand two hundred dollars (\$25,200.00), and further that such latter amount is not subject to adjustment or refund but shall be retained by the Applicant company.

The agreement further provides for the lease of the underwater portion of the gas main from the Applicant company to the Customer for the period during which gas is to be delivered and for the sum of one dollar (\$1.00) per year.

The Company agrees to maintain and otherwise perform all necessary work on said underwater portion of gas main for the account of Customer and at Customer's sole risk, cost and expense.

The period of the agreement is from the first date of service, which shall be on or about October first, 1938, and until the expiration of the succeeding twelve months and thereafter until terminated by thirty (30) days' written notice by either party but not later than the date of termination of the heretofore referred to Exposition.

The proposed agreement also contains a statement that it shall at all times be subject to such changes and/or modifications as the Commission may from time to time direct in the exercise of its jurisdiction.

Inasmuch as both parties to the proposed agreement are desirous of entering into the same, and the Commission is of the opinion that the performing of the covenants thereof will not constitute a burden to Applicant's other customers; that a public hearing in the matter is not necessary and, good cause appearing therefor,

IT IS HEREBY ORDERED that the Pacific Gas and Electric Company is hereby authorized to execute an agreement with San Francisco Bay Exposition in terms as set forth in Exhibit "A" attached to the application herein, and to consummate said agreement in accordance with its terms and provisions.

IT IS HEREBY FURTHER ORDERED that the Pacific Gas and Electric Company shall file said agreement with the Commission within thirty (30) days after its execution.
