ELEVENTH SUPPLEMENTAL OPINION AND ORDER

By petition filed September 21, 1938, the Draymen's Association of Alameda County seeks an order modifying Decision No. 29217, as amended, in Cases Nos. 4108 and 4109, by providing a changed basis of rates to be effective for a temporary period for the transportation of groceries within the East Bay drayage area. Petitioner asks that a flat rate of 15 cents per 100 pounds, minimum charge 50 cents per shipment, be established as minimum for the transportation of groceries

in shipments of all sizes from docks, rail cars, highway trucks or manufacturers' stocks in Alameda County to retailers or consumers within the East Bay drayage area, and that such rate be made to supersede, temporarily, the present zone class and commodity rates. It is represented that a changed method of distribution, brought about by a strike condition existing in Alameda County, necessitates the establishment of the basis sought.

Upon consideration of the circumstances and conditions shown, and good cause appearing,

IT IS HEREBY ORDERED that Appendix "A" of Decision No. 29217, as amended, in the above entitled proceedings, be and it is hereby further amended by adding the following new item to Section 3 page 24 thereof:

Commodity

Groceries and Grocers' Supplies, as described in Note 4 on pages 3, 4 and 5 of Appendix "B" to Decision No. 30682, when moving from docks, rail cars, highway trucks or manufacturers' stocks to retailers or consumers

Rate

15 cents por 100 pounds, Minimum charge 50 cents per shipment

In all other respects said Decision No. 29217, as amended, shall remain in full force and effect.
