31319 Decision No. BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA WALGINAL In the Matter of the Application of V. FRED JAKOBSEN, an individual, doing business under the firm name and style of SPECIAL DELIVERY SERVICE CO., to sell, and ARNOLD ADDLESTONE, on individual, to purchase an automotive freight line (parcel delivery service) operated between San Leandro, Ala meda, Application No. 22251 Oakland, Piedmont, Emeryville, Berkeley, Albany and El Cerrito, and intermediate points. BY THE COMMISSION: OPINION V. Fred Jakobsen operating under the name and style of Special Delivery Service Co. has petitioned the Railroad Commission for an order approving the sale and transfer by him to Arnold Addlestone, an individual, of an operating right for the automotive transportation as a highway common carrier of property between San Leandro, Alameda, Oakland, Piedmont, Emeryville, Berkeley, Albeny and El Cerrito and intermediate points; and Arnold Addlestone, en individual, has petitioned for authority to purchase and acquire soid operating right and to hereafter operate thereunder, the sale and transfer to be in accordance with an agreement, a copy of which, marked Exhibit "A", is attached to the application herein and made a part thereof. The consideration to be paid for the property herein proposed to be transferred is given as \$17,140.62. Of this sum \$7,140.62 is alleged by the applicant to be the value of the ecuipment and \$10,000 is alleged to be the value of the intangibles. The operating right herein proposed to be transferred was created by Decision No. 28246, dated September 30, 1935 on Application No. 19884 -1This appears to be a matter in which a public hearing is not necessary. The application will be granted.

Arnold Addlestone is hereby placed upon notice that "operative rights" do not constitute a class of property which should be capitalized or used as an element of value in determining reasonable rates. Aside from their purely permissive aspect they

extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be changed or destroyed at any time by the state which is not in any respect limited to the number of rights which may be given.

## ORDER

IT IS HEREBY ORDERED that the above entitled application be, and the same is hereby granted, subject to the following conditions:

- 1. The consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission, or any other rate fixing body, as a measure of value of said property for rate fixing, or for any purpose other than the transfer herein authorized,
- 2. Applicant Arnold Addlestone shall within twenty (20) days after the effective date of the order herein unite with applicant V. Fred Jakobsen in common supplement to the tariffs on file with the Commission, covering service given under the certificate herein authorized to be transferred, applicant V. Fred Jakobsen withdrawing and applicant Arnold Addlestone accepting and establishing such tariffs and all effective supplements thereto.
- 3. Applicant V. Fred Jakobsen shall within twenty (20) days after the effective date of the order herein withdraw all time schedules filed in his name with the Railroad Commission and applicant Arnold Addlestone shall within twenty (20) days after the effective date of the order herein file, in duplicate, in his own name time schedules covering service heretofore given by applicant V. Fred Jakobsen which time schedules shall be identical with the time schedules now on file with the Railroad Commission. in the name of applicant V. Fred Jakobsen or time schedules satisfactory to the Railroad Commission.

4. The rights and privileges herein authorized may not be sold, leased, transferred nor assigned, nor service there-under discontinued, unless the written consent of the Rail-road Commission to such sale, lease, transfer, assignment or discontinuance has first been obtained. 5. No vehicle may be operated by applicant Arnold Addlestone unless such vehicle is owned by said applicant or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission. 6. The authority herein granted to sell and transfer the right and/or property shall lapse and be void if the parties hereto shall not have complied with all the conditions within the periods of time fixed herein unless, for good cause shown, the time shall be extended by further order of the Commission. 7. Applicant shall, prior to the commencement of service authorized herein and continuously thereafter comely with all the provisions of this Commission's General Order No. 91.
