SUPPLEMENTAL OPINION

By this supplemental application Pacific Greyhound Lines seeks authority to reroute its service via the new state highway being completed between Lodi Airport and Galt in lieu of the old highway between Lodi Airport and Forest Lake as heretofore set for in paragraph #29, Decision No. 23244, dated December 31, 1930 on Application No. 16989, covering its operations between Sacramento and Stockton and a re-defining of said route.

In justification of the authority herein sought applicant alleges that the State Highway Department is rerouting state route No. 4 (U.S. 99) between Lodi Airport and Galt eliminating the narrow bridge over Dry Creek, south of Galt and providing thereby a more direct route of operation. It further alleges that there are no intermediate points on the route now operated between Lodi Airport and Forest Lake which will be abandoned under the proposed rerouting.

This appears to be a matter in which a public hearing is not necessary. The application will be granted.

O R D E R

IT IS HEREBY ORDERED that Pacific Greyhound Lines be and it is hereby authorized to reroute its service via the new state highway between Lodi Airport and Galt in lieu of its presently

operated service between Lodi Airport and Forest Lake via the old highway and to abandon service via said old highway between the points of Lodi Airport and Forest Lake.

IT IS HEREBY FURTHER ORDERED that paragraph #29, Decision No. 23244 dated December 31, 1930 on Application No. 16989 be and it is hereby amended to read as follows:

"29. Between Sacramento and Stockton

- a - Via state route 4 through Galt, Lodi Airport and Lodi;
- b - Between Galt and Stockton as follows:
 - (1) old state route No. 4 between Galt and Forest Lake
 - (2) county highway between Forest Lake and Woodbridge
 - (3) state route No. 53 between Woodbridge and Lodi
 - (4) Sargent Road, Woodbridge Road and Lower Sacramento Road between Lodi and Stockton

subject to the following condition:

- (1) Applicant shall file on at least ten (10) days' notice to the Commission and the public a supplement to its tariff in triplicate and a schedule in duplicate in conformity with the authority herein granted.

The effective date of this order shall be the date hereof.
