OPINION AND ORDER

By this application, as amended, authority under Section 10 of the City Carriers' Act and Section 11 of the Highway Carriers' Act is sought by F. Teskey to transport paper, paper articles and related commodities as a city carrier and a highway contract carrier, between points within the Los Angeles drayage area, at lesser charges than those accruing under minimum rates established in and by Decision No. 30600 of February 7, 1938, as amended, in Case No. 4121. The commodities proposed to be transported and the rates sought to be charged are set forth in Exhibit "A" of the application. The shippers intended to be served are not named specifically, but the principal ones are indicated as being Fibreboard Products, Inc., Pioneer-Division Flintkote Company, Glass Containers, Inc., and Standard Paper Box Corporation.

It is alleged in the application that the established minimum rates are excessive for the transportation performed by applicant, and, moreover, that they have resulted or will result in the loss to another carrier or to proprietary carriage of substantially all of the traffic enjoyed heretofore by applicant. In support of the first allegation it is stated that certain economies are possible in an operation of this nature and that due to the specialization in commodities handled high load and use factors are

obtained. It is contended that these advantages justify the maintenance of rates lower than those established for carriers performing a general transportation service. In support of the second allegation it is stated that one of the companies for whom applicant transported considerable tonnage in the past has already commenced a proprietary operation and now gives applicant only the overflow tornage. It is asserted, moreover, that a shipper who has been utilizing applicant's service for the past three years and whose tonnage constitutes approximately 75 per cent of Teskey's total business, has discontinued shipping via this carrier in favor of Reader Transportation Service, a carrier who has already been granted authority to assess rates lower than the established minimum rates for similar transportation. Letters written to applicant by the shippers hereinbefore mentioned, notifying him that use of his services was being discontinued in favor of proprietary operations or Reader Transportation Service, and stating that he would not be given any tonnage in the future unless lower rates were accorded, were submitted with the application.

The opinion is expressed by applicant that the sought rates will be fair, just and reasonable for the transportation involved and that they are sufficient in volume to return a profit over and above the cost of performing the service.

It is apparent from the allegations in the application that applicant will be deprived of the greater portion of his tonnage unless rates lower than the established minimum rates are made evailable. It seems evident, moreover, that Teskey should not be

By Decision No. 31330 dated October 3, 1938, in Application No. 22086, A. R. Reader and Phil Reader, doing business as Reader Transportation Service, were authorized to transport a large group of paper, paper articles and related commodities within the Los Angeles drayage area, for numerous shippers, at rates comparable to those here sought for the lower weight brackets and somewhat higher for the greater minimum weights.

required to charge higher rates than are charged by a competing carrier offering a similar service. It cannot be determined definitely from the allegations in the application whether or not the precise rates sought will be reasonable and compensatory. It does appear, however, that the rates which Reader Transportation Service has heretofore been authorized to charge will be reasonable for this applicant and he will be granted authority similar to that held by such competing carrier without the necessity of a public hearing. If additional authority is desired, applicant should so notify the Commission and a public hearing will be scheduled.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that applicant F. Teskey be and he is hereby authorized to assess and collect for the transportation for which rates are provided in Appendix "A" attached hereto and by this reference made a part hereof, rates less than the minimum rates heretofore established by the Commission but not less than those provided in said appendix.

IT IS HEREBY FURTHER ORDERED that the authority herein granted shall expire one (1) year from the effective date of this order unless sooner changed, cancelled or extended by appropriate order of the Commission.

This order shall become effective on the date hereof.

Commencing at the intersection of Atlantic Avenue and Florence Avenue; west on Florence Avenue to Vermont Avenue; north on Vermont Avenue to Fountain Avenue; east on Fountain Avenue to Hyperion Street; northeast on Hyperion Street to Rowena Street; southeast on Rowena Street to Fletcher Drive; northeast on Fletcher Drive to Casitas Avenue; northwest on Casitas venue to Rosslyn Street; northeast on Rosslyn Street to the Union Pacific right of way; southeast on the Union Pacific right of way to Isabel Street; southeasterly on Isabel Street to Griffin Avenue; south on Griffin Avenue to North Broadway; east on North Broadway to Mission Road; southwest on Mission Road to Valloy Boulevard; east on Valloy Boulevard to Marianna Avenue; south on Marianna Avenue to Eastern Avenue; south on Eastern Avenue to Whittier Boulevard; east on Whittier Boulevard to Atlantic Avenue; thence south on Atlantic Avenue to point of commencement.
