SEVENTEENTH SUPPLEMENTAL OPINION AND ORDER

By petitions or written requests, W. H. Caltoft, doing business as Sausalito. Stinson Beach and Bolinas Auto Line: D. S. Mitchell, doing business as Mitchell's Stages; Henry B. Elbert, doing business as The Arvin Line; Barl C. Cook, doing business as Cook's Stages; A. H. Weston and W. H. Curson, doing business as Weston & Curson Stage Line; and A. H. Weston, doing business as Woodland-Rumsey Auto Stage, seek exemption from application of Decision No. 30370, as amended, in the above entitled proceedings, as to shipments weighing 100 pounds or less. In general, these carriers allege that their respective freight and express operations are conducted in connection with passenger stage services or with the distribution of mail for the United States Government; that such operations consist chiefly of the transportation of small shipments on frequent schedules; that they are similar in all essential respects to operations of carriers heretofore granted a

similar exemption; and that they are not competitive to any serious extent with other carriers as to which the minimum rates are applicable.

It appears from the allegations made that the operations for which exemption is being sought are peculiar in nature and substantially similar to those of carriers who have already been exempted. The requested relief will be granted.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that paragraph (o) of Rule 20, Appendix "A" of Decision No. 30370 dated November 29, 1937, as amended, in the above entitled proceedings, be and it is hereby further amended by adding as exempted carriers Earl C. Cook, doing business as Cook's Stages; W. H. Caltoft, doing business as Sausalito, Stinson Beach and Bolinas Auto Line; D. S. Mitchell, doing business as Mitchell's Stages; Henry B. Elbert, doing business as The Arvin Line; A. H. Weston and W. H. Curson, doing business as Weston & Curson Stage Line; and A. H. Weston, doing business as Woodland-Rumsey Auto Stage, for the transportation of shipments of property weighing 100 pounds or less.

In all other respects said Decision No. 30370, as amended, shall remain in full force and effect.

The effective date of this order shall be the date hereof.
