BY THE COMMISSION:

OBINION

J. Nelson Kagarise in these proceedings seeks authority to abandon highway common carrier operations, (a) between Los Angeles and Los Angeles Harbor, on the one hand and Baldwin Park, Covina, Azusa, Glendora, San Dimas, La Verne, Pomona, Claremont, and Upland, on the other hand (Application No. 22296); (b) and between Los Angeles and Puente (Application No. 22297).

Public hearings were had in these matters and melated (1) proceedings which were consolidated therewith on January 4 and 5, and February 23 and 24, 1939, and having been taken under submission are now ready for decision. Prior to the submission of these matters an order was made dissolving the order of consolidation with respect to Applications Nos. 22296 and 22297, to permit a separate decision thereon.

In regard to Application No. 22296, applicant alleges that due to SMall Volume of traffic moving under the right therein involved, the service has been operated at a loss for the past year. Kagarise testified that there had been no demand for any service under such right for more than six months prior to the filing of his application for authority to abandon the right. In fact, he could not recall ever having performed any service under such right which was originally created by the Commission's Decision No. 16035, dated March 2, 1926, in which a certificate was granted to Edmond H.

De Marr authorizing a "demand service".

In regard to the request in Application No. 22297 to abandon service between Los Angeles and Puente, applicant Kagarise testified that it had been some time since any service had been

performed by him between such points. The right between Los Angeles and Puente was originally created by the Commission's Decision No. 10752, dated July 21, 1922 on Application No. 7884, in which a certificate was granted to R. L. McMichael. The service authorized was a regularly scheduled service for the transportation of general commodities subject to certain minor restrictions.

In view of the showing made in these matters, it appears to be in the public interest to authorize applicant to abandon the services as proposed in his applications, and an order will be entered accordingly.

ORDER

A public hearing having been held thereon and the Commission now being duly advised,

IT IS ORDERED that J. Nelson Kagarise is hereby authorized to abandon all operations as a highway common carrier between Los Angeles and Los Angeles Harbor on the one hand, and Baldwin Park, Covina, Azusa, Glendora, San Dimas, La Verne, Pomona, Claremont, and Upland on the other hand, and between Los Angeles and Puente, and the operative rights therefor created by Decision No. 25184, dated September 19, 1932, and Decision No. 27619, dated December 22, 1934, respectively, are hereby revoked and annulled and all tariffs and time schedules now on file with the Railroad Commission

in the name of J. Nelson Kagarise covering rates and services between such points are hereby cancelled.

The effective date of this order shall be twenty (20) days from the date hereof.
