OPINION

In these applications California milk Transport, Inc. requests authority to abandon certain operative rights for the transportation of dairy supplies, which include hay, feed, grain and other commodities, as a back haul movement between Los Angelos and other points.

By Decision No. 29568, dated March 1, 1937, on Application No. 21014, applicant California Milk Transport, Inc. was authorized to establish an automotive operation for the transportation of milk, cream and dairy products and for a return movement of empty containers and dairy supplies, which include hay, feed, grain and other commodities, between dairies and creameries in the territory between Los Angeles, Newport Beach and Fullerton and intermediate points. By Decision No. 31454, dated November 10, 1938, on Application No. 22120, applicant was authorized to establish an automotive service for the transportation of milk, cream and dairy products with a return movement

of empty containers and dairy supplies, which include hay, feed, grain and other commodities, between Los Angeles, Pasadena, Montebello, Alhambra, El Monte, Baldwin Park, Puente and intermediate points.

Applicant herein requests authority to abandon transportation of dairy supplies on the back haul movement between the aforesaid points and a revocation of the operative rights therefor so that applicant will not be obliged to continue to file tariffs covering such commodities to comply with the various orders of the Commission.

As justification for the authority sought applicant alleges that in the conduct of said operations it has been unable to obtain the back haul of dairy supplies between the points herein involved.

This is not a matter requiring a public hearing and the request appearing to be in the public interest will be granted.

IT IS OADERED that California Milk Transport, Inc. is hereby authorized to discontinue the transportation of dairy supplies as a back haul movement between Los Angeles, Newport Beach, Fullerton and intermediate points, and the operative right therefor, heretofore created by Decision No. 29568, dated march 1, 1937, is hereby revoked and annulled.

IT IS FURTHER ORDERED that California Milk Transport, Inc. is hereby authorized to discontinue the transportation of dairy

supplies as a back haul movement between Los Angeles, Pasadena, Montebello, Alhambra, El Monte, Baldwin Park and Puente and intermediate points and the operative right therefor, heretoforo created by Decision No. 31454, dated November 10, 1938, is hereby revoked and annulled.

Applicant shall publish and file in its tariff within thirty (30) days from the effective date hereof and on not less than ten days' notice to the Commission and the public a cancellation of the rates for the service herein authorized to be discontinued and abandoned.

The effective date of this order shall be the date hereof.
