ORIGINAL EY THE COMMISSION: ELEVENTH SUPPLEMENTAL OPINION AND ORDER By this supplemental application, Motor Transit Company, a corporation, requests authority to further suspend until October 1, 1940, the re-establishment and operation of its passenger stage service over and along the following routes: From Ontario northerly along Euclid Avenue to the intersection of Euclid Avenue with Foothill Boulevard thence via Foothill Boulevard to San Bernardino. 2. Beginning at the intersection of Ninth Street and Euclid Avenue in the city of Upland, thence via Ninth and Tenth Streets to the Arrow Highway, thence via the Arrow Highway through Cucamonga, Fontana and Rialto to San Bernardino. From the intersection of Whittier Boulevard 3. From the intersection of whiteled bounds. (7th Street) and Boyle Avenue, Ninth Street, Mines Avenue and Montebello Boulevard to Whittier Boulevard. The Commission has heretofore ordered applicant to resume service over the above described operation on or before March I, 1939, or to relinquish the operative right therefor. (Decision No. 29660, dated April 5, 1937, on Application No. 20948) Subsequently, a further suspension was authorized until October 1, 1939, in view of certain studies involving the operations of Pacific Electric Railway Company -1-
