ORDER

Frank Atkinson reports that he is engaged in the business of carrying passengers by bus from the termini of Manchester and Broadway, East to Avalon Boulevard, South to 120th Street, West to San Pedro Street, South to 121st Street, West to Main Street to point of beginning and reverse over the same route, all in Los Angeles County. For 1936 he had operating revenues of \$12,565.22. To continue in the business he finds it necessary to acquire two 25-passenger Yellow Coaches, Model No. 1204, at a cost of \$4,434.47 each. Four hundred forty-five dollars and forty-seven cents of the purchase price is payable in cash with the order and the balance in thirty-six equal monthly installments of \$116.66, as set forth in the Conditional Sales Contracts on file in this proceeding. He requests permission to execute such Conditional Sales Contracts.

The Commission has considered applicant's request and is of the opinion that this is not a matter in which a hearing is necessary, that the money, property or labor to be procured or paid for by the execution of said Conditional Sales Contracts is reasonably required by applicant and that this application should be granted, subject to the provisions of this order, therefore,

IT IS HEREBY ORDERED that Frank Atkinson be, and he is hereby, authorized to execute, on or before March 1, 1940, Conditional Sales Contracts with the General Motors Truck and Coach Division of Yellow Truck and Coach Manufacturing Company covering the unpaid balance (\$4,200 on each) on two 25-passenger Yellow Coaches, Model No. 1204, such Conditional Sales Contracts to be substantially in the same form as the Conditional Sales contract filed in this proceeding.

IT IS HEREBY FURTHER ORDERED that the authority herein granted will become effective when Frank Atkinson has paid the minimum fee prescribed by Section 57 of the Public Utilities Act, which minimum fee is Twenty-five(\$25.00) Dollars.

IT IS HEREBY FURTHER ORDERED that within thirty(30) days after the execution of each of said Conditional Sales Contracts Frank Atkinson shall file with the Railroad Commission a copy of each contract executed, under the authority herein granted.
