THIRD SUPPLEMENTAL ORDER

The Commission's Order in its Decision No. 31605, dated December 27, 1938, as amended by Decision No. 31991 of May 9, 1939, in the above-entitled cases dealt with the matter of determining constructive mileages for the public highways of the State of California.
