O P I N I O N

Applicant Glenn S. Martin under the authority of operative right created by the Commission in its Decision No. 29389, dated December 21, 1936, on Application No. 20315, is providing a seasonal passenger stage service between Palm Springs and Cathedral City from approximately September 15 to June 1 of the following year. Applicant is also providing a seasonal passenger stage service between Blue Jay and Cedar Glen from approximately June 1 to September 10 of each calendar year. In this application, as amended, authority is sought to change the operating period of such rights as follows: between Palm Springs and Cathedral City from October 1 to May 30 of the following year, and between Blue Jay and Cedar Glen from July 15 to September 15 of each calendar year. Authority is also sought to temporarily suspend for the current season applicant's operation between Blue Jay and Cedar Glen.

As justification for the authority sought applicant avers to the effect that there is insufficient traffic to warrant his operation between Blue Jay and Cedar Glen for the remainder of the current season.

This is not a matter in which a public hearing is necessary and the authority requested will be granted. The authority to change

the dates between which each of the two seasonal services will be operated will be granted by amending the language of applicant's present certificate as set forth in Decision No. 29389.

O R D E R

IT IS ORDERED that the language of the order of Decision No. 29389 reading as follows:

"(a) Palm Springs and Cathedral City and intermediate points as a seasonal service from approximately September 15th to June 1st over and along the following route:..."

is hereby amended to read:

"(a) Palm Springs and Cathedral City and intermediate points as a seasonal service from approximately October 1st to May 30th of the following calendar year over and along the following route:..."

IT IS FURTHER ORDERED that the language of the order of Decision No. 29389 reading as follows:

"(b) Blue Jay and Cedar Glen via State Highway No. 59-E as a seasonal service from approximately June 1st to September 10th."

is hereby amended to read:

"(b) Blue Jay and Cedar Glen via State Highway No. 59-E as a seasonal service from approximately July 15th to September 15th of each calendar year."

IT IS FURTHER ORDERED that Glenn S. Martin is hereby authorized to suspend his passenger stage service between Blue Jay and Cedar Glen for the remainder of the current season.

Applicant shall immediately file, in triplicate, time schedules giving effect to the authority herein granted.

The effective date of this order shall be the date hereof.
