BY THE CONAISSION:
OPINION AND ORDER

In this appication Pacific Ges and Zlectric Company, hereinarter sometimes rererred to as Applicant, requests authority to enter into a written agreement with Acme Breweries, hereinafter sometimes called Customer, relatins to the sale and delirery of surpaus netural gas as shall durins the term of the agreement be required for fiel purposes in the operation of Customer's highpressure boilers (1050 i.p. rated capacity) at its plant loceted at Kebster and Fulton Streets, San Frencisco, Colirornia. A copy OI the proposed agreement marked Exhioit "A" is attached to and made a part of the applicetion.

Some of the more important ieatures and conditions of said proposec agreement may oe set forth. ipplicant agrees, if and when it shall have surplus gas available, to sell and deliver to Customer, gna the latter agrees to purchase from tine fommer, such quantities of the same as shall curing the term of the agreement be required for fuel purposes in bollers used for other than building beating purposes in Customer's plant; and Customer further egrees to use surylus gas as tioe exclusive fuel in the
operation of said plant.
The proposed agreement shall supersede the agreement between the two parties dated October 6, 1936 and which will terminate as of September 16, 1940.

The rates to be charged are in accordance with the following:

First 7,500,000 Cu. It per month - 24.0\& per 1000 Cu. Ft. Next 7,500,000 Cu.Ft. per month - 12.0£ per 1000 Cu. Fit. A11 excess cu.Et. per month - 11.5申 per 1000 cu.Ert.

The above rates are subject to adjustment based upon the price of fuel oil and an ennual minimu payment of $\hat{\text { in }} 12,000.00$, payabie at the rate of 解, 000.00 per month.

The term of the proposed agreement is for a period of three years from and after september 16,1940 and sinell continue therearter from year to year; provided, however, that either party hereto shall have the right to terminate said agreement at the expiration of the initial term thereof, or any subsequent contractual year by givins the other written notice to that effect at least thirty (30) days prior to saic termination date.

The agreement contains a provision that it shail at all times be subject to such changes or modifications by the Rajiroad Comission of the state of California as said Commission may from time to time direct in the exercise of its jurisciction.

The comission naving considered the request of the Applicact and it being of the opinion that the application shourd be granted, that a pubilc hearine in the matter is not necessary and good cause appearing, tiorefore

IT IS ORDERW that Facific Ges and Inectric Company is bereby autiorized to enter into that certain proposed agreement with Acme Breweries, set forth as Exhibit "A" attached to the within application, and to render surplus natural gas service to
said Acme Breweries at the rates and under the terms and conditions set forth in said agreement; provided, however, that the authority herein granted shell not be taken as limiting the Commission's authority to modify or set aside such agreement by appropriate order.

Pacific Gas enc Electric Company shall file two copies of the agreement with the commission within thirty (30) days after its execution.

Authority herein granted shall become effective as of the date hereof.
