## <u>OPINION</u>

By this application A. H. Weston and W. H. Curson, doing business as Weston and Curson Stage Line, seek authority to abandon all their operative rights for the transportation of passengers, baggage, and express, between Woodland and Robbins via Knights Landing, heretofore authorized by Decision No. 12190, on Application No. 9098, Decision No. 15768, on Application No. 12280 and Decision No. 31702, on Application No. 22325.

As justification for the granting of the authority sought it is alleged that the revenue derived from the passenger stage service is noncompensatory, and that during the period from June 1 to September 30, 1940, inclusive, the gross revenue derived from their operation amounted to \$371.10. The operating cost during this same period, exclusive of depreciation on equipment and office expense, amounted to \$373.47.

It is further alleged that applicants made a survey of the territory along the route proposed to be abandoned and found no opposition to the proposed discontinuance of service, provided that Pacific Greyhound Lines institute a comparable service over the route sought to be abandoned. Such service was inaugurated on November 1, 1940.

This duplication of service appears unnecessary and will result in further loss of revenue. Under these circumstances it appears that the public interest does not require the continuance of the service herein sought to be abandoned. This appears to be a matter in which a public hearing is not necessary. The application will be granted.

## OBDER

IT IS ORDERED that A. H. Weston and W. H. Curson be and they hereby are authorized to discontinue and abandon all of their rights for the transportation of passengers, baggage, and express between Woodland and Robbins via Knights Landing and intermediate points, and the operative right therefor, heretofore created by the Commission's Decisions Nos. 12190, 15768, and 31702 are hereby revoked and annualled.
