In this proceeding Northwestern Pacific Railroad Company requests that it be authorized to remove or modify the protection at certain crossings at grade in its interurban territory of Marin County upon the withdrawal of interurban electric passenger train service. It is alleged that after the withdrawal of said passenger train service infrequent freight service will be operated over the lines involved.

It appears that this is not a matter in which a public hearing is necessary and that the application should be granted with certain modifications as hereinafter specified, therefore

Northwestern Pacific Railroad Company is hereby authorized to remove or modify the protection at certain crossings in its interurban territory in Marin County upon the abandonment of interurban electric passenger train service, as follows:

- All crossings where signals are authorized to be removed shall continue to be protected by at least one (1) Standard No. 1 crossing sign (G.O. 75-B)
- (2) Applicant shall, within thirty (30) days thereafter, notify this Commission, in writing, of the modification of crossing protection and of its compliance with the provisions hereof.
- (3) The authorization herein granted shell lapse and become void if not exercised within one (1) year from the date hereof, unless further time is granted by subsequent order.

(4) The Commission reserves the right to make such further orders relative to the protection of said crossings as to it may seem right and proper, if in its judgment public convenience and necessity demand such action.
