In the Matter of the Joint Application of HANNAH MARIE ALLEN to sell, and D. MOYERS, to purchase, certain passenger stage operative rights for the transportation of passengers, baggage and express between Fresno and Parlier, and between Fresno and Del Rey, California.

BY THE COMMISSION:

<u>O P I N I O N</u>

By the above-entitled application Hannah Marie Allen seeks permission to sell and D. Moyers requests authority to purchase certain passenger stage operative rights between Fresno, Parlier, Sanger and Del Rey.

Hannah Marie Allen is the widow of Carl C. Allen who, before his death, operated a passenger stage service under the name of Anchor Stages between Fresno and Parlier via Sanger and between Fresno and Del Rey. The operative rights and equipment formerly owned by Mr. Allen were distributed to his wife by the Decree of Final Distribution in the Superior Court of the State of California in and for the County of Fresno. Mrs. Allen has not had experience in transportation matters and does not desire to try to continue to operate the service formerly conducted by her husband. Hence, she asks authority to sell and transfer the operative rights and equipment referred to above to D. Moyers.

Mr. Moyers presently operates a passenger stage service between Fresno, Gilroy, Los Banos, Tracy, Merced, Madera and other

points. He requests that the Allen rights be consolidated with those he now owns if the application is granted, so that all may be operated as one unified system. The consideration to be paid by Moyers to Hannah Marie Allen for the property (two trucks), the operative rights and the good will of the business is the sum of three thousand dollars. It appears that Moyers is financially able to continue the service heretofore rendered by Allen.

Full consideration has been given to this matter. The Commission is of the opinion that a public hearing is unnecessary and that public convenience and necessity require that this application be granted.

ORDER

Based upon this application and the evidence pertaining thereto,

IT IS ORDERED as follows:

(1) That Hannah Marie Allen is authorized to transfer the passenger stage operative rights and automotive equipment formerly owned by her husband, Carl C. Allen, which she acquired by the Decree of Final Distribution of the Superior Court of the State of California in and for the County of Fresno, in the matter of the estate of Carl C. Allen, deceased, to D. Moyers.

(2) That D. Moyers is authorized to acquire the operative rights and property above referred to and to consolidate such operative rights with and make them a part of those he now owns.

(3) That Hannah Marie Allen and D. Moyers comply with Rule 9 of General Order No. 79 by filing in triplicate within sixty

days from the effective date of this order and upon not less than five (5) days' notice to the Commission, a withdrawal and adoption notice as required by said general order.

(4) That D. Moyers comply with Part IV of General Order No. 93-A within sixty (60) days from the effective date of this order and upon not less than five (5) days' notice to the Commission and the public.

The effective date of this order shall be the date hereof.
