## THIRD SUPPLEMENTAL ORDER

Pasadena City Lines, Inc., on May 27, 1941, filed with the Commission a request for abandonment of its service in Altadena, as authorized by Decision No. 33750, dated December 21, 1940, which service was installed for a trial period.

Pasadena City Lines, Inc., now advises that during the 91-day period from January 19th to April 19th, 1941, the total operating revenues for the Altadena service were \$552.94 and the operating expenses amounted to \$1,477.68, leaving a loss of \$924.74.

Applicant desires to abandon this service effective Saturday June 28, 1941, the day after the public schools of Pasadena and Altadena close for the summer vacation.

It appears that insufficient patronage has developed to continue this service on a permanent basis; that this is not a matter in which a public hearing is necessary; and that the request should be granted, therefore

IT IS HEREBY ORDERED that Pasadena City Lines, Inc., be and it is hereby authorized to abandon passenger stage service on its Altadena line, described as follows:

## ALTADENA ROUTE:

From a point at the intersection of Lake Avenue and Mariposa Street; northerly on Lake Avenue to Los Flores Drive; westerly on Los Flores Drive to Fair Oaks Avenue; southerly on Feir Oaks Avenue to Palm Street; westerly on Palm Street to Olive Avenue; southerly on Clive Avenue to Ventura Street; westerly on Ventura Street to Lincoln Avenue; southerly on Lincoln Avenue to the intersection of Lincoln Avenue and Figueroa Drive, where it will connect with the Lincoln Avenue Line, returning over the same route in the opposite direction;

and to cancel in conformity with the rules of this Commission all rate tariffs and time schedules applying to said service, subject to the following conditions:

- (1) Said abandonment shall be made effective not before the close of business on Saturday, June 28, 1941.
- (2) Applicant shall give at least five days' notice to the Commission and the public of said abandonment.

The effective date of this order shall be the date hereof.
