OPINION

William E. Merritt and Thomas W. Hale, a co-partnership operating under the fictitious name and style of Merritt-Hale Bus Service, have petitioned the Railroad Commission for an order approving the sale and transfer by them to Ray Withers and Andrew Byrd, a co-partnership, of an operating right for the automotive transportation of passengers as a passenger stage corporation, as such is defined in Section 2-1/4 of the Public Utilities Act, between King City and Hearst Ranch Airport and intermediate points; and Ray Withers and Andrew Byrd have petitioned for authority to purchase and acquire said operative right and to hereafter operate thereunder, the sale and transfer to be in accordance with an agreement, a copy of which marked Exhibit MAT is attached to and made a part of the application.

The consideration to be paid for the property herein proposed to be transferred is given as \$400.00, which is alleged by applicants to be the value of the intangibles. No equipment is proposed to be transferred.

The operative right herein proposed to be transferred was created by Decision No. 33690 dated December 3, 1940 on Application No. 23789 and the application shows that the Merritt-Hale Bus Service has been continuously operated since its lawful inception pursuant to schedules and tariffs on file with the Commission.

After full consideration of this matter the Commission is of the opinion that a public hearing is not necessary and that the public interest will be subserved by the granting of this application.

ORDER

It having been found that public convenience and necessity so require,

Hale, a co-partnership, are hereby authorized to transfer to Ray Withers and Andrew Byrd, a co-partnership, the passenger stage corporation operative right referred to in the foregoing opinion, and Ray Withers and Andrew Byrd are hereby authorized to acquire said operative right and to hereafter operate thereunder.

IT IS FURTHER ORDERED that (1) William F. Merritt,
Thomas W. Hale, Ray Withers and Andrew Byrd comply with Rule 9
of General Order 79 by filing in triplicate with sixty (60) days
from the effective date of this order and upon not less than
five (5) days' notice to the Commission and the public, a withdrawal and adoption notice as required by said General Order;
and (2) Ray Withers and Andrew Byrd comply with Part IV of
General Order 93-A within sixty (60) days from the effective date

of this order and upon not less then five (5) days' notice to the Commission and the public.

The effective date of this order shall be the date hereof.
