BY THE COMMISSION:

O R D E R

L. D. Bohnett, Jr., an individual, dba Alum Rock Bus Line, is operating a passenger stage service between San Jose and Alum Rock Park as a seasonal service between approximately May 1 and October 1 on Sundays and holidays only in conformity with a certificate issued in accordance with an operative right created by this Commission's Decision No. 29897, dated June 26, 1937, on Application No. 21153. San Jose City Lines, Inc., proposes to acquire this operative right and consolidate it with the remainder of its system operating within the City of San Jose and its environments.

It appears that this is not a matter in which a public hearing is necessary and that the application should be granted.

## IT IS ORDERED

I. That L. D. Bohnett, Jr., is authorized to transfer the passenger stage common carrier operative right granted to him by Decision No. 29897 on Application No. 21153 to the San Jose City Lines, Inc., and the latter is granted the right to acquire said operative right and hereafter to operate said service as an extension and enlargement of its existing passenger stage system and consolidated therewith.

II. That L. D. Bohnett, Jr., dba Alum Rock Bus Line, and San Jose City Lines, Inc., comply with General Order No. 79, by filing in triplicate within sixty (60) days from the effective date of this order and upon not less than five (5) days' notice to the Commission a withdrawal and adoption as required by said General Order.

III. That San Jose City Lines, Inc., comply with Part IV of General Order No. 93-A within sixty (60) days from the effective date of this order and upon not less than five (5) days' notice to the Commission and the public.

IV. That the route of said operations shall be modified to read as follows:

The proposed route will be the same as the present Santa Clara and Linda Vista Lines of San Jose City Lines, Inc., as shown on map, Exhibit "B," attached to the application except that operations will be extended from Alum Rock Avenue and Miguelito Road to Alum Rock Park.

The authority herein granted shall become effective on the date hereof.
