O P I N I O N

Mattie Caltoft, as administratrix of the estate of Walter H. Caltoft, deceased, has petitioned the Railroad Commission for an order approving the sale and transfer by her to Charles H. Cunningham and A. A. Wilkins of an operative right for the automotive transportation of passengers and property as a common carrier between Sausalito, Stinson Beach and Bolinas; and Charles H. Cunningham and A. A. Wilkins have petitioned for authority to purchase and acquire said operative right and hereafter to operate thereunder. The sale and transfer is to be in accordance with an agreement, a copy of which, marked Exhibit "A," is attached to the application herein and made a part thereof.

The consideration to be paid for the property herein proposed to be transferred is given as \$250. No equipment is involved in the transfer.

The operative right herein proposed to be transferred was acquired by decedent under authority of the Commission's

Decision No. 9581, dated September 30, 1921, on Application No. 7205. The application shows that service under that right has been provided continuously for the past two years on a daily basis.

Full consideration has been given to this matter. The Commission is of the opinion that a public hearing is unnecessary and that public convenience and necessity require that the application be granted.




Good cause appearing,

IT IS ORDERED that Mattie Caltoft, as administratrix of the estate of Walter H. Caltoft, deceased, is hereby authorized to transfer to Charles H. Cunningham and A. A. Wilkins the operative right referred to in the foregoing opinion; and Charles H. Cunningham and A. A. Wilkins are hereby authorized to purchase and acquire said operative right and hereafter to operate thereunder.

IT IS FURTHER ORDERED that applicants herein shall comply with the rules of the Commission's General Orders Nos. 79 and 80 and with Part IV of the Commission's General Order No. 93-A by filing in triplicate tariffs and time schedules as required by such rules, within sixty (60) days from the effective date of this order and upon not less than five (5) days' notice to the Commission and the public.

The effective date of this order shall be the date hereof.
