OPINION

Pacific Greyhound Lines, as part of its state-wide system, operates through Salinas over U.S. Highway No. 101, which is sometimes referred to as the Coast Route. At Salinas three branch lines connect with the Coast Route. These three branch line operations extend from Salinas to Watsonville, Monterey and Fort Ord, respectively.

In its operations within the city of Salinas applicant has established service over certain routes so as to reach its depot at Gabilan and Salinas Streets, and the Southern Pacific depot near the intersection of Main and Market Streets. In this application the Commission is requested to make its order prescribing the routes within that city, subject to the conditions, that in the conduct of its operations within that city, applicant may use any combination of routes so specified and that its motor vehicles may be turned at the termini or stations either in adjacent street intersections or by operating around a block contiguous to any such intersection in either direction as required by local traffic regulations.

As evidenced by a resolution attached to the application the city council of Salinas, after full consideration, has

approved the proposed routing. This does not appear to be a matter in which a public hearing is necessary and the request will be granted.

ORDER

IT IS ORDERED that Pacific Greyhound Lines, in its operation of a passenger stage service over routes originating or terminating at, or passing through the city of Salinas pursuant to certificates of public convenience and necessity heretofore granted by Decision No. 25147, (Application No.18303), Decision No. 23244, (paragraphs 64 and 65), (Application No. 16989) and Decision No. 32725, (Application No. 23046) shall comply with and observe the following service regulation:

Subject to the authority of this Commission to change or modify them at any time by further order, operations within the city of Salinas shall be conducted over and along the following routes:

1. Route between Salinas and Chittenden Road Junction:

Southbound - Entering the City on U.S. Highway 101 (State Route 1), to north Main Street, thence via north Main Street to Monterey Street, thence via Monterey Street to Gabilan Street, thence via Cabilan Street to Salinas Street, to rear entrance of Company's depot.

Northbound - From Company's depot to Gabilan Street, thence via Gabilan Street to Monterey Street, thence via Monterey Street to north Main Street, thence via north Main Street to U.S. Highway 101 (State Route 1).

2. Route between Salinas and Chualar:

Northbound - Entering the city on U.S. Highway 101 (State Route 1) to Abbott Street, thence via Abbott Street to John Street, thence via John Street to Salinas Street, thence via Salinas Street to rear entrance of Company's depot.

Southbound - From Company's depot to Gabilan Street, thence via Gabilan Street to Salinas Street, thence via Salinas Street to John Street, thence via John Street to Abbott Street, thence via Abbott Street to U.S. Highway 101 (State Route 1).

3. Route between Salinas and Monterey:

Northbound - Entering the City on State Route 117 (Salinas-Monterey Road) to south Main Street, thence on south Main Street to John Street, thence on John Street to Salinas Street, thence on Salinas Street to rear entrance of Company's depot, thence from Company's depot to Gabilan Street, thence on Gabilan Street to Lincoln Street, thence via Lincoln Street to Natividad Street, thence on Natividad Street to Southern Pacific depot.

Southbound - From the Southern Pacific depot to Natividad Street, thence on Natividad Street to Lincoln Street, thence on Lincoln Street to Gabilan Street, thence on Gabilan Street to Salinas Street, thence on Salinas Street to rear entrance of Company's depot, thence from Company's depot to Gabilan Street, thence on Gabilan Street to Salinas Street, thence on Salinas Street to John Street, thence on John Street to South Main Street, to Salinas-Monterey Road (State Route 117).

4. Route between Salinas and Fort Ord:

Northbound - Entering the City of Salinas-Blanco Road to Central Avenue, thence on Central Avenue to Lincoln Street, thence on Lincoln Street to Gabilan Street, thence on Gabilan Street to Salinas Street, thence on Salinas Street to Company's depot.

Southbound - From Company's depot to Gabilan Street, thence on Gabilan Street to Lincoln Street, thence on Lincoln Street to Central Avenue, thence on Central Avenue, to Salinas-Blanco Road.

5. Route between Salinas and Castroville:

Southbound - Entering the City from Salinas-Watsonville Road (State Route 118), thence to Market Street, thence on Market Street to Lincoln Street, thence on Lincoln Street to Gabilan Street, thence on Gabilan Street to Salinas Street, thence on Salinas Street to Company's depot.

Northbound - From Company's depot to Gabilan Street, thence on Gabilan Street to Lincoln Street, thence on Lincoln Street to Market Street, thence on Market Street to Salinas-Watsonville Road. (State Route 118).

The effective date of this order shall be the date hereof.
