## ORDER IN APPLICATION NO. 21904 SUPPLEMENTAL ORDER IN APPLICATION NO.

In Application No. 24904 the People of the State of Califormia, on relation of the Department of Public Works, request authority to construct crossings at grade with tracks of Southern Pacific Company at three locations in the City of Richmond. These crossings are necessary in connection with the building of a Naval Industrial Access Road between El Cerrito Hill Overhead, Albany, and Potrero Avenue, Richmond. At two of these points there are existing crossings of minor streets with the tracks at approximately the locations proposed for the new highway. At one of these existing crossings, that of Meeker Street with the Seaver Avenue load track, Crossing No. A-13.57-C, the Commission recently authorized Southern Pacific Company, in Application No. 24888, Decision No. 35213, to construct an additional track, thereby forming a wye. The wye track had not been constructed at the time of the filling of the instant application and is therefore not included in the application. Authority to cross the wye track, if and when constructed, will be given in the

present order but the cost of constructing and protecting the crossing is still an obligation of Southern Pacific Company.

The protection specified in Decision No. 35213 in the applicetion of Southern Pacific Company was based on crossing what was then

cation of Southern Pacific Company was based on crossing whatwas then an unimportant minor street and not an arterial highway. Decision No. 35213 should therefore be modified to provide Standard No. 8 crossing signals and flood lighting. Since such signals and lighting would also protect the crossing with the existing track, for which the Department of Public works is now making application, its cost should be borne fifty per cent by each party.

Southern Pacific Company, in stating its position in regard to this application, requests that the Commission in effect commit itself with respect to its action on some future application which the company may find necessary in connection with a relocation of its so-called 2nd Street drill. Such commitment can not be made. Neither can we require the Department of Public Works to grant a permit for this track or for the proposed wye track across property acquired by the State on either side of Meeker Street. The application of the Department of Public Works for the crossing will be granted subject to certain conditions and proper modification of Decision No. 35213 made.

IT IS HEREBY ORDERED that the Dopartment of Public Works of the State of California is authorized to construct a Naval Industrial Access Road across spur and lead tracks of Southern Pacific Company at Richmond, Contra Costa County, at the locations described in the application, to be identified as follows:

Spur track at Engineer's Station 128 as Crossing No. A-12.9-C,

Spur track at 47th Street as Crossing No. A-13.3-C, replacing an existing crossing with the same number.

Seaver Avenue load track and a wye track at list and Meeker Streets as Crossing No. A-13.57-C, replacing an exist-ing crossing with the same number.

Applicant shall bear entire construction expense, excepting as hereinafter provided, also maintenance cost outside of lines two

feet outside of rails. Southern Pacific Company shall bear maintenance cost between such lines. Width of crossings shall conform with adjacent portions of the highway and gradus of approach shall not excoed three per cont. Construction shall be equal or superior to Standard No. 2 of G. O. No. 72. Protection shall be by two Standard No. 1 crossing signs (G. O. No. 75-B) at Crossing No. A-12.9-C and by two Standard No. 8 crossing signals at Crossing No.A-13.3-C and Crossing No. A-13.57-C. Crossing No. A-13.57-C shall be floodlighted. The cost of protection prescribed at Crossing No. 13.57-C shall be borne fifty per cent by the Department of Public Works and fifty per cent by Southern Pacific Company. Maintenance of the Standard No. 8 crossing signals at both crossings shall be by Southern Pacific Company and applicant shall maintain the floodlighting at Crossing No. A-13.57-C. This order shall not be construed as relieving Southern Pacific Company of the cost of constructing its proposed wye track across the highway.

The crossings authorized in this order may be opened to public use pending the installation of the special protection ordered herein, provided traffic on the highway be protected by a member of the train crew or other competent employee of the railroad company acting a s a flagman.

IT IS HEREBY FURTHER ORDERED that Decision No. 35213 in Application No. 24868 is modified to provide that the grades of approach of the crossing therein authorized shall not exceed three per cent and that said crossing shall be protected with Standard No. 8 crossing signals.

In all other respects Decision No. 35213 is in full force and effect.

Within thirty days after completion pursuant to this order, applicant shall so advise the Commission in writing. This authorization shall become void if not exercised within one year, unless time

be extended, or if above conditions are not complied with. Authorization may be revoked or modified if public convenience, necessity or safety so require. This order shall be effective immediately.
