SUPPLEMENTAL ORDER

By Decision No. 35219, as amended, in the above proceedings, Violet M. Keller, doing business as Menlo Park and San Francisco Parcel Delivery, was ordered to cancel, effective not later than May 15, 1942, on not less than one (1) day's notice to the Commission and the public, rates published in Local Freight Tariff No. 4, C.R.C. No. 2, which tariff had theretofore been suspended, and to file in lieu thereof a tariff containing rates consistent with and reflecting the operative authority which she was found by the opinion to possess. Thereafter, on April 27, 1942, Violet M. Keller filed a petition for rehearing of Decision No. 35219. By petition filed May 13, 1942, Violet M. Keller requests an extension of the time within which to cancel the aforesaid Tariff No. 4 and within which

to file another tariff in lieu thereof until such time as the petition for rehearing is disposed of.

Upon consideration of the petition the Commission is of the opinion that the time for such compliance should be extended to June 10, 1942 and that an order suspending said Local Freight Tariff No. 4, C.R.C. No. 2, should be similarly extended.


Therefore, good cause appearing,

IT IS HEREBY ORDERED that the second ordering paragraph of the order, as amended, in Decision No. 35219, be and it is hereby further amended by substituting the date June 10, 1942, for the date May 15, 1942 which now appears in the second line of said paragraph as amended.

IT IS FURTHER ORDERED that Local Freight Tariff No. 2, C.R.C. No. 2, of Violet M. Keller be and it is hereby further suspended until June 10, 1942, and it is directed that a copy of this order be filed with said tariff in the office of the Commission.

The effective date of this order shall be the date hereof.
