INTERIM ORDER

J. C. Forkner, Inc., a corporation, and Robert L. Forkner and Muriel Forkner, his wife, having filed an amended application in the above entitled proceeding, requesting authority to sell and transfer for \$8,300 the water distribution system and appurtenances thereto serving Beverly Park area in the vicinity of Fresno, California, to the Fresno County Water Works District No. 3, a public corporation, and it appearing that this is not a matter in which a public hearing is necessary and that this application should be granted, now, therefore,

IT IS HEREBY ORDERED that J. C. Forkner, Inc., a corporation, and Robert L. Forkner, and Muriel Forkner, his wife, be and they hereby are authorized to sell and transfer on or before October 1, 1942 to the Fresno County Water Works District No. 3, their public utility water distribution systems and appurtenant properties supplying water service to residents in the Beverly Park area in the vicinity of Fresno, California, subject to the following terms and conditions:

1. On or before the first day of October 1942, J. C. Forkner, Inc., a corporation, and Robert L. Forkner and Muriel Forkner, his wife, shall refund all amounts, if any, for deposits made for main extensions, meter or service connections, and for any other purposes, and on or before the sixth day of October 1942, they shall file with this Commission a certified statement to the effect that any and all such deposits have been refunded.
2. Within thirty (30) days after the transfer of said properties, J. C. Forkner, Inc., a corporation, and Robert L. Forkner and Muriel Forkner, his wife, shall file with this Commission a certified copy of the final instrument or instruments of conveyance for the properties herein authorized to be transferred.
3. Within thirty (30) days after the transfer of said properties, J. C. Forkner, Inc., a corporation and Robert L. Forkner, and Muriel Forkner, his wife, shall file with this Commission a certified statement indicating the date upon which they actually relinquished control and possession of the properties herein authorized to be sold and transferred.

For all other purposes, the effective date of this Order shall be twenty (20) days from and after the date hereof.
