FIRST SUPPLEMENTAL OPINION

In the above-entitled supplemental application, Dean A. Conyers seeks a license authorizing him to engage in the business of a Motor Transportation Broker, pursuant to Chapter 705, Statutes of 1935. Accompanying the application is a list of carriers whom Conyers proposes to serve together with letters of authority from those carriers designating Conyers as their transportation representative. A surety bond, continuous in form, was filed with the original application.⁽¹⁾

By Decision No. 34480, dated August 12, 1941, in Application No. 24026, the Commission licensed Conyers to act as a Motor Transportation Broker. This license expired on December 31, 1941, as provided for in section 7 of the Motor Transportation Brokers' Act. At the public hearing on that application it was established, as stated in the opinion of that decision, that Conyers was a full-time salaried employee of American Storage

Company of Los Angeles, the fictitious name under which the Pacific States Savings and Loan Association functions as a warehouseman for used household goods, personal effects and office and store fixtures and equipment. It was there found that the applicant was an experienced and competent person fully capable of performing the duties of a Motor Transportation Broker.

It appears from the application that Conyers has arranged to represent approximately sixty-four carriers which hold highway contract, radial highway common carrier, and/or city carrier permits.

This is not a matter in which a public hearing is necessary. The application should be granted as provided for in the following order.

SUPPLEMENTAL ORDER

A supplemental application therefor having been filed and the Commission being fully informed therein:

IT IS ORDERED that Dean A. Conyers is hereby granted a license to engage in the business or act in the capacity of a Motor Transportation Broker, as defined in Chapter 705, Statutes of 1935, only at the following location, to-wit: 3634 Beverly Boulevard, Los Angeles, California; to sell, offer for sale, negotiate for, furnish or provide and hold himself out to sell, negotiate for, furnish or provide transportation of property over

(2) Located at 3634 Beverly Boulevard, Los Angeles, California, the address at which the licensed brokerage business of applicant is to be conducted.

the public highways of this state to be furnished only by the carriers hereinafter designated, subject to the following conditions:

1. Applicant shall, within sixty (60) days from the effective date hereof, provide and file with the Railroad Commission a good and sufficient surety bond in the sum of one thousand (\$1,000) in accordance with the provisions of section 8 of said Act and in a form prescribed or approved by the Railroad Commission.

2. A license certificate issued pursuant hereto shall be posted by applicant at the address therein shown for public inspection.

3. This license shall expire on December 31, 1942, subject to the provisions for renewal prescribed by the Commission; provided, however, that this license shall be inoperative and of no force and effect during a period when there shall not be in effect and on file with the Railroad Commission for said applicant a good and sufficient surety bond in accordance with the provisions of said section 8 of said Act and the rules and regulations of the Railroad Commission.

IT IS FURTHER ORDERED that upon said Dean A. Conyers filing with the Commission a surety bond as hereinabove provided, the secretary of the Railroad Commission be and he is hereby authorized and directed to issue and deliver to said Dean A. Conyers a certificate of the authority hereby granted.

IT IS FURTHER ORDERED that the license of Dean A. Conyers shall authorize him to sell, offer for sale, negotiate for, furnish or provide and hold himself out to sell, negotiate for, furnish or provide transportation of property over the public highways of this state to be furnished only by the carriers whose names, addresses and permit numbers follow, to wit:
