BY THE COMMISSION:

THIRD SUPPLEMENTAL ORDER

Fresno City Lines, Inc., in its First Supplemental Appli-  
 cation asks for permission to reroute a portion of its passenger  
 stage service between Fresno and U. S. Army Air Base (Hammer Field),  
 as described in Second Supplemental Order of Decision No. 34963, in  
 order to better serve an intermediate territory known as Beverly Park  
 located on McKinley Avenue and east of North Fresno Street.

Applicant proposes the change in route for a period of  
 ninety (90) days and if sufficient patronage develops it will con-  
 tinue this operation.

It appears that this is not a matter in which a public  
 hearing is necessary and that the request should be granted, therefore

IT IS HEREBY ORDERED that the description of applicant's  
 passenger stage service between Fresno and the U. S. Army Air Base  
 (Hammer Field), as described in Condition (2), Section II, of Decision  
 No. 34404, as amended by Decisions Nos. 34931 and 34963, be and it  
 is hereby further amended to read as follows:

- (2) Subject to the authority of this Commission to change or modify such at any time in the future, conduct such passenger stage operation over and along the following route:

Commencing at the intersection of Mariposa Street and Broadway, thence east along Mariposa Street past the station of the Santa Fe Trailways to Fulton Street, thence along Fulton Street to Fresno Street, thence north on Fresno Street to Fresno Avenue, thence north on Fresno Avenue to Floradora Avenue, thence east along Floradora Avenue to First Street, thence north along First Street to McKinley Avenue, thence west along McKinley Avenue to Fresno Avenue, thence north along Fresno Avenue to Shields Avenue, thence east along Shields Avenue to a point about one-fourth of a mile west of Clovis Avenue opposite the Air Base (Hammer Field), returning via the same route.

In all other respects Decision No. 34404 shall remain in full force and effect.

The effective date of this order shall be the date hereof.
