ORDER

The verified application of Sacramento Northern Railway discloses that no passenger or freight business has been transacted at a number of applicant's stations for more than two years and that the amount of business handled at several others no longer warrants their continued maintenance as stations of record.

These stations were established primarily as passenger stops at a time when applicant was operating passenger service. Such service has now been discontinued and the elimination of the stations will enable applicant to simplify its records and effect economies in publishing its tariffs and other schedules.

Good Cause Appearing, Sacramento Northern Railway is authorized to abandon the non-agency stations listed in Exhibit "A" attached hereto, to remove spur tracks at stations so designated in said Exhibit "A," and to retire the passenger shelters and freight handling facilities which may exist at said stations, to eliminate said names from its station records, and to cancel all tariffs and time schedules applying at said stations on not less than one day's notice to the Commission and the public.

Within thirty days after abandonment and removal of the facilities, as authorized herein, applicant shall so notify the Commission in writing. This authorization shall become void if not exercised within one year, unless time be extended. This order shall

be effective immediately.
