SUPPLEMENTAL OPINION AND ORDER

By virtue of Decision No. 35271 of April 14, 1942, in the above entitled proceedings, the rates of common and highway contract

carriers were increased, with certain exceptions, by six per cent for the transportation of property generally, and by three per cent for the transportation of basic raw products of agriculture, animal products and products of mines. The increased minimum rates established by this decision for radial highway common carriers and highway contract carriers were made effective April 24, 1942. Thereafter, the Office of Price Administration, acting under the Emergency Price Central Act of 1942, issued its General Maximum Price Regulation providing, in general, that the maximum price for any commodity or service shall be the highest obtaining during March, 1942. In so far as it pertained to highway contract carriers this regulation became effective August 1, 1942. Common carrier services were specifically exempted.

On behalf of the highway contract carriers whose minimum rates had been increased by Decision No. 35271, supra, this Commission petitioned the Office of Price Administration to authorize the increased rates prescribed by that decision. The petition has been denied. Under the circumstances the minimum rates established by this Commission for highway contract carriers should not exceed the highest in effect during March, 1942. The ferce of the competition between contract and common carriers may require the latter in many instances to observe the rates of the former. For this reason the increases in minimum rates established for radial highway common carriers by the aforesaid Decision No. 35271 will likewise be rescinded. Other common carriers finding it necessary to reduce their rates for competitive reasons should make appropriate tariff fillings.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Highway Carriers' Tariffs Nos. 2, 4 and 7, issued in Case No. 4246, and Highway Carriers' Tariff No. 8 issued in Caso No. 4293, be and they are hereby amended by making a part of each of the aforesaid tariffs, as Supplement. 2 thereof, said supplement, which is attached hereto and by this reference made Appendix "A" hereof.

IT IS HEREBY FURTHER ORDERED that in all other respects said Decision No. 35271 shall remain in full force and effect.

This order shall become effective twenty (20) days from the date hereof.
