O P I N I O N

By supplemental applications filed November 18, 1942, and December 2, 1942, A. J. Chapin has requested certain minor reroutings and an alternate routing of his present operations between Sacramento and McClellan Field and intermediate points.

The alternate routing sought is near Ben Ali, by which applicant would be able to avoid, when necessary, the use of a grade crossing of Southern Pacific rail lines by the use of an underpass on El Camino Avenue.

The minor reroutings sought would require modification of Route No. 5 and Route No. 7, as defined in Decision No. 35675, which would enable it to better serve certain recently developed housing facilities in the vicinity of McClellan Field.

The authority sought appears to be in the public interest and will be granted. This is not a matter requiring a public hearing.

O R D E R

Good cause appearing,

IT IS ORDERED as follows:

(1) That Route No. 1 of the service regulations of Decision No. 35675 (Application No. 25106) is hereby amended by the addition thereto of the following route description:

From the junction of Ben Ali Avenue and Marconi Avenue southwesterly along Auburn Boulevard to El Camino Avenue; thence westerly along El Camino Avenue to Del Paso Boulevard or to Rio Linda Boulevard (9th Street).

(2) That Routes Nos. 5 and 7 of the service regulations of said Decision No. 35675 are hereby amended to read as follows:

ROUTE 5

Along Nogales Avenue between Rio Linda Boulevard and Marysville Boulevard to Marysville Boulevard, thence on Marysville Boulevard and Los Robles Avenue to the junction of Los Robles Avenue and Del Paso Boulevard (Haggin Oaks Store). From the junction of Marysville Boulevard and Los Robles Avenue to 18th Street to Verano Street to the junction of Del Paso Boulevard.

ROUTE 7

Beginning at the intersection of Marysville Road and Grand Avenue, thence along Marysville Road to Bell Avenue, thence along Bell Avenue to the United States Army Air Depot (McClellan Field). Beginning at the intersection of 16th Street and North Avenue, thence along 16th Street to Bell Avenue. Beginning at the intersection of Bell Avenue and 24th Street, thence south on 24th Street to North Avenue, thence on North Avenue, Marysville Boulevard, Grand Avenue, to 22nd Street, continuing easterly along Claremont Avenue to the junction of Claremont Avenue and Ben Ali-Antelope Road. Beginning at the junction of North Avenue and Oak Street along Oak Street to Grand Avenue.

(3) That said Decision No. 35675 shall in all other respects remain in full force and effect.
