O P I N I O N

By Decision No. 34097, in Application No. 23322, Long Beach Motor Bus Company was granted authority to establish and operate a passenger stage service between Long Beach and Bellflower and intermediate points. The route of operation between those points was defined in the service regulations of the order thereof. Thereafter by supplemental order (Decision No. 34173, in 2nd Supplemental Application No. 23322) certain modifications of that route were authorized.

In the application being considered Long Beach Motor Bus Company has requested minor changes in that route to better serve the needs of those traveling to and from Lakewood City. It is asserted that the proposed route change will entail an additional one-way mileage of only 0.3 miles. There will be no changes in fares or schedules over the line involved.

Applicant's request appears to be in the public interest and will be granted. No public hearing appears to be necessary.

ORDER

IT IS ORDERED that the description of the route of operation between Long Beach and Bellflower, as set forth in service regulation No. 2 of Decision No. 34097, as modified by Decision No. 34173, is hereby further amended to read as follows:

"Beginning at the intersection of Ocean Boulevard and Pine Avenue, Long Beach, thence north on Pine Avenue to East Broadway, thence east on East Broadway to American Avenue, thence south on American Avenue to East Ocean Boulevard, thence east on East Ocean Boulevard to Cherry Avenue, thence north on Cherry Avenue to Spring Street, thence east on Spring Street to Lakewood Boulevard, thence north on Lakewood Boulevard to Harvey Way, Lakewood Village, thence east on Harvey Way to Tulane Avenue, thence south on Tulane Avenue, to Village Road, thence southeasterly along Village Road to Viking Way, thence northeasterly along Viking Way to Bellflower Boulevard, thence northerly along Bellflower Boulevard to its intersection with Center Street, Bellflower. Along East Ocean Boulevard between its intersections with Pine Avenue and American Avenue, Long Beach."

In all other respects Decision No. 34097 shall remain unchanged and in full force and effect. Decision No. 34173 is superseded hereby.

The effective date of this order shall be the date hereof.
